Dear Alumni:

Progress has been the theme around Gardner-Webb College during the past year. We enrolled over 1,000 students. The trustees entered a million dollar plus campaign with Mr. R. Patrick Spangler of Shelby as National General Chairman. The campaign will be a success. The college adopted its first budget of over a million dollars. An A.A. Degree Nursing Education program and an I.B.M. Data Processing School have been added to the curriculum. Approximately 1,450 new applications have come in for the coming year. A campus center, a men's dormitory, and the covering of the swimming pool are under construction. The Boiling Springs Baptist Church is building an educational building with a sanctuary to follow. Plans are being made for the stadium, a classrooms building, a fine arts center, and a chapel-religious activities center.

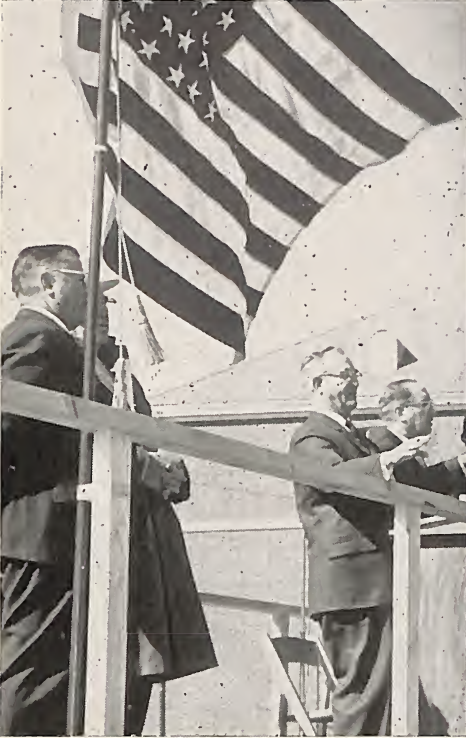

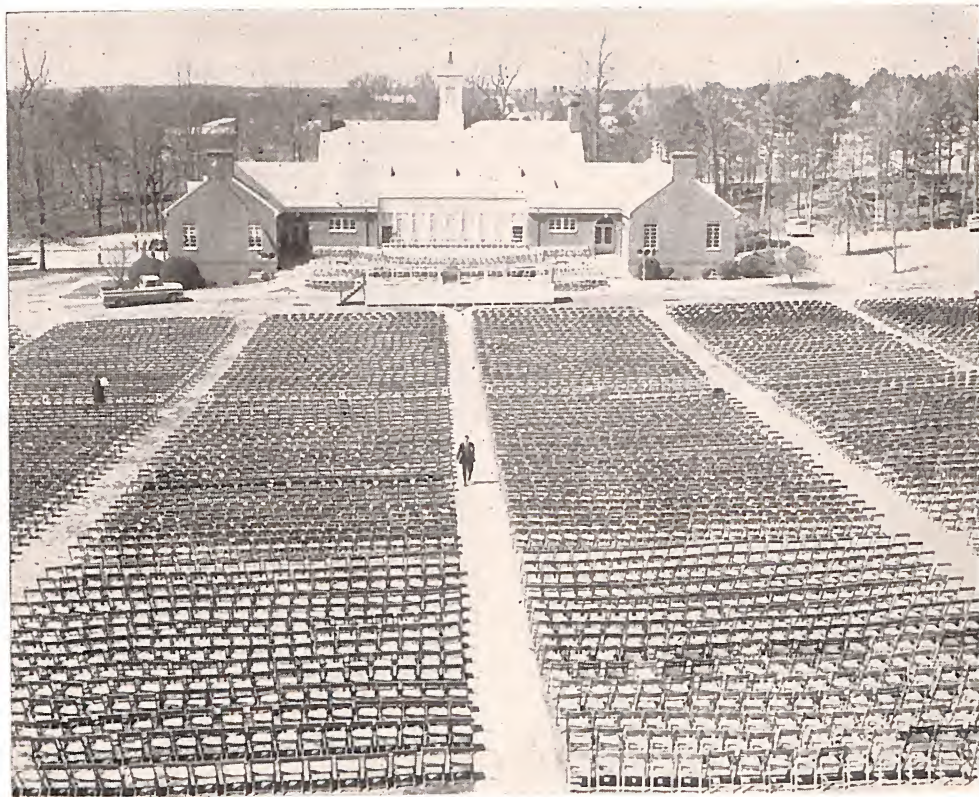

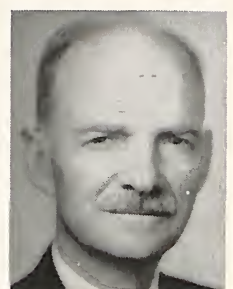

# LUTZ-YELTON OFFICIALS NAME DORMITORY

One of the two new dormitories for men at G-W will be named the Lutz-Yelton Dormitory by four Shelby businessmen.

J. Ray Lutz, Lloyd L. Lutz, Flay Oren (Red) Champion and Paris L. Yelton representing the Lutz-Yelton Companies and its stockholders have made a substantial donation to the college's \$1,125,000 campaign, says R. Patrick Spangler, general chairman. Spangler went on to say that the dormitory located between the A. T. Withrow Science Building and Bost Physical Education Building will be named in honor of the organization headed by these men.

The following are stockholders: Robert H. Lutz, Ray Webb Lutz, William D. Lutz, J. P. Henderson, W. A. Pernell, Bob Yelton, Don Yelton, Mrs. Lynn Lutz Carpenter, Gary Roberts, Charles Mauney, and Mr. & Mrs. Joe Hamrick.

The new Lutz-Yelton Dormitory is constructed to accommodate 100 men. Constructed of solid masonry, the three and one-half story building was completed in 1963 and occupies a prominent position on a sloping hill adjacent to the main quadrangle of the college campus. There is an additional men's dormitory under construction adjacent to the Lutz-Yelton Dormitory.

"These four outstanding Cleveland County businessmen have expressed through their actions a firm belief in the future of Gardner-Webb College," said Dr. Poston.

All four of these men are Baptists, members of the Shelby First Baptist Church and natives of Cleveland County. J. Ray Lutz and Paris Yelton were in business together as early as 1929 and in 1930 Lloyd and Ray Lutz founded the Auto Inn.

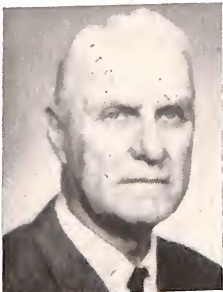

# CITY OF SHELBY EXPRESSES CONFIDENCE IN G-W WITH \$687,868 IN GIFTS

City of Shelby leaders in Gardner-Webb College's expansion program have sent their campaign \$15,418.74 pass the \$150,000 goal. Immediately after co-chairmen, Hoyt Bailey and Harvey Hamrick, completed tallies of their organization's successful campaign, R. Patrick Spangler, national general chairman rose to tell the gathering in the college's O. Max Gardner Building just how difficult the task had been.

"Before you people started working we had already raised \$522,450 in the City of Shelby. We knew this \$150,000 goal would be one of the toughest ones in the entire campaign and its wonderful you have made it," Spangler told the leaders. He went on to say Shelby's total gifts now amount to \$687,868.74. This broken down came in this way from Shelby residents: \$223,700 from Gardner-Webb trustees, \$172,975 from Gardner-Webb Advisors, \$100,275 through Leadership Gifts headed by Robert Forney, '31, \$25,500 from other special gifts and the \$165,418.74 through general organization and special gifts.

Lagging by \$12,132 on June 1, Shelby's general organization voted to hold one more report session and June 14 just-

ified the move, reporting \$27,590. Of this amount \$4,325 came from general solicitation, \$1,500 from special gifts headed by William Humphreys and \$19,600 turned in by Bailey as special gifts.

Bailey and Hamrick join with several other successful chairmen of drives completed in the \$1,125,000 campaign. The Boiling Springs area under Jim Beason surpassed its \$26,000 goal by nearly \$3,000, Robert Forney's Leadership Gifts Committee topped its \$125,000 goal by over \$13,000, college trustees passed a \$400,000 goal by \$40,470, college advisors set a goal of \$200,000 and pledged over \$237,000 and the faculty, staff, administration and Slater Food Service employees at the college passed their \$20,000 goal by \$10,275.

## Annual Dedication Is To Mr. Stacy

The 1965 edition of *The Anchor* was dedicated in May to Paul John Stacy, assistant professor of biology at Gardner-Webb College for 24 years.

Annual editor, Samuel Covington of Rockingham, made the dedication during a chapel service in the gymnasium. This was the second time the yearbook has been dedicated to Mr. Stacy. The first time was in 1945.

Professor Stacy is a graduate of Duke University and has done additional studies at Duke.

## Upper Cleveland Tops Its Goal

Upper Cleveland County nearly doubled its goal of \$15,000 for Gardner-Webb College's program of expansion. The area reported \$28,633 during its final report session July 1.

Ralph Spangler was chairman of the successful drive in which \$16,633 came in from special gifts and general organization work and \$12,000 from a special gift.

Jim Cline headed the general organization and James Petty was chairman of the special gifts committee. John Washburn's team led the general organization with \$2,095 reported followed by Hill Dameron's team with \$1,970. T. S. Putnam's Division "A" in Lawndale was the leading division with \$6,030 and second was Robert Borders' division in Waco-Belwood-Fallston with \$4,815.

Our educational system has never stood still. Gardner-Webb College has never stood still.

Even as we contemplate the four-year program we must look even further. For one day, there must come a time in which we must weigh what we have done, are doing and will do in the balances.

Yes, those who follow will read the record and make a judgment as to the worth of our part in the College's future. Every alumnus should be vitally interested and concerned for the success of our work and be ready to share in its completion.

The campaign currently underway is meeting with good success. It needs the participation of all of us if it is to be a real success. Resolve now to be a part of it.

### Spangler Brothers Boost Athletic Program

A football stadium and track will be constructed at Gardner-Webb College within the next two years and will be known as the Spangler Memorial Stadium, announces Dr. E. Eugene Poston, president of the college.

The fully equipped athletic facility will be named by R. Patrick Spangler and Earl Webb (Bud) Spangler, both of Shelby, in memory of their father, Ernest Webb Spangler and in honor of their mother, Mrs. Verna Patrick Spangler.

R. Patrick Spangler, presently serving as overall chairman of the college's major 60th Anniversary Phase of the Decade of Advance program and his brother, Earl (Bud) Spangler, a former student at Gardner-Webb, are active supporters of the college. Pat Spangler is also on the college board of advisors.

The Spangler brothers own and operate Spangler and Sons Concrete Co. in Shelby, Spangler Ready Mix Concrete Co. in Kings Mountain and the Shelby Sand and Stone, Inc. of Shelby.

Earl Spangler, a 1946 alumnus of the college, attended the University of North Carolina. He is vice-president of First Federal Savings and Loan in Shelby, a Kiwanis Club member, member of the Shelby First Baptist Church and is married to Evelyn Harrill Spangler. The couple has four children.

Pat Spangler played a major role in Cleveland County's industrial development through his work with the Shelby Chamber of Commerce. State-wide recognition of his ability came when Gov. Terry Sanford appointed him in 1963 to gather Shelby businessmen for North Carolina Day at the World's Fair. He also served as a Trade Fair delegate to Europe and has been active on other state level posts.

A Rotarian, Mason, and Shriner, Spangler was awarded the "Citizen of the Year" award by Shelby Lions in 1963. He is married to the former Eloise

### V. F. Hamrick Gives Large Gift

A former assistant athletic director at Wake Forest College has given Gardner-Webb College a substantial stock gift to be used in construction of an athletic fieldhouse adjacent to the proposed new Spangler Memorial Stadium.

V. F. Hamrick, 80, of 933 W. Warren St. in Shelby, was told June 14 during a final report meeting of the Shelby area campaign, that trustees of the college have voted unanimously to name the fieldhouse in his honor.

Plans are now being drawn for a stadium and fieldhouse which will be located south of the Bost Physical Education Building on the present athletic field. R. Patrick Spangler and his brother, Earl Webb (Bud) Spangler, both of Shelby, gave a substantial gift to the college stadium fund and named it in honor of their mother, Mrs. Verna Patrick Spangler and in memory of their father, Ernest Webb Spangler.

Hamrick attended Wake Forest College in 1904-1908 and while there served under Coach Dick Crozier as assistant athletic director. His interest in athletics is keen and for many years he was one of the most avid fans of Shelby's professional baseball teams. "I realize the need of more physical activity in our schools and colleges and have never lost my love of athletics," Hamrick said.

A regular contributor to the Wake Forest athletic program and to his church, Hamrick said, "I could not resist the opportunity to assist a growing college like Gardner-Webb and am proud to be a part of such a worthy cause as higher Christian Education."

## Achievers Cited

Four outstanding Cleveland and Rutherford counties citizens were honored by Gardner-Webb College during commencement exercises.

Rev. C. C. Crow of Shelby and a native of Rutherford County, Bertie Lee Kendrick, '41, of 102 Georgia St. Spindale; Laura Cornwell and D. W. Royster both of Shelby, were presented citations for their contributions to area, state, church and civic life.

Rev. Crow was born in 1900 in Rutherford County, is a graduate of Hollis High School and Wake Forest College. The retired Baptist minister completed high school when 30 years old, married and with two children. He has been pastor of 14 churches in the Sandy Run, Green River and Kings Mountain Associations, was moderator of the Sandy Run Association in 1960-1962 and of the Kings Mountain Association in 1952-1954. Rev. Crow was named "Rural Minister of the Year" in 1952 by the *Progressive Farmer*.

Miss Kendrick is a missionary to Hawaii. Born in Henrietta, she graduated from the Henrietta-Caroleen High School in 1927, Boiling Springs Junior College in 1941, Furman University in 1943 and went on for seminary training at the New Orleans Baptist Seminary.

She has worked in foreign missions for the Southern Baptist Convention for 20 years and is presently "on loan" to the Hawaii State Convention. Miss Kendrick helped in the development of three Baptist Churches on the Maui Island of Hawaii and has served in other capacities on the mission field.

Miss Cornwell was principal of Marion School in Shelby for 25 years and later went to Hawaii where she served as principal of a Baptist School for eight years.

A member of Shelby's First Baptist Church, Miss Cornwell is a graduate of Woman's College of U.N.C. in Greensboro and has done additional study at Duke, U.N.C. at Chapel Hill, A.S.T.C. and the Univ. of Calif.

## College Calendar Is Revised

Gardner-Webb College is making a dramatic change in its 1965-1966 academic calendar.

The school year will begin Aug. 25 with the arrival of first year and transfer students and the first semester will be concluded with examinations before Christmas holidays begin on Dec. 17.

Second semester registration is set for Jan. 10-11 and the school year ends May 15 with graduation.

"We have studied this plan and find that the few colleges and universities in the Carolinas who have switched to this schedule have noted an improved academic program," stated Dr. Poston.

Some of the schools now on this calendar include Phiffer, Clemson University, Winthrop in Rock Hill, the University of South Carolina, and beginning this year, N. C. State University at Raleigh.

The calendar gives the same number of class hours for the first semester as are now attended under the old program, but an additional three class hours will be attended in the spring of 1966.

The calendar is: Aug. 25, 26, 27 and 28 registration, orientation, etc. Aug. 30, first classes, Oct. 21-22, mid term; Nov. 24-29, Thanksgiving holidays; Nov. 6, Homecoming; Dec. 11-17, final examinations. Second semester registration begins. Jan. 10-11 and classes resume Jan. 12. March 3-4 is mid-term, April 8-18 is for Easter holidays, final exams are set for May 7-13, Alumni Banquet, May 14, and graduation is May 15.

is one of our ages' most dangerous learning, surpassing that of the Iron Curtain or the Bamboo Curtain."

Dr. E. W. Price, Jr., pastor of the Green Street Baptist Church of High Point and president of the General Board of the Baccalaureate Sermon to consider "help wanted" signs developing among the nations protestant churches.

Dr. Price was joined at Gardner-Webb College by another convention official, Dr. How-

ard J. Ford, president of the convention and pastor of Wilmington's Winter Park Baptist Church. Dr. Ford brought the Literary Address during commencement exercises.

Speaking on "Christ and the Individual Person", Dr. Ford said in our complex age there is little hope of slowing the massive growth of government bureaus and even of church organizations but he challenged the graduates to remember "man's worth or else lose their precious freedoms."

In a morning address, Dr. Price spoke of the individual but in a different vein as Dr. Ford. He stressed the dangers signaled by a 36 percent decline in our colleges of students studying for fulltime Christian work, pointing out that although 1,800 missionaries are now on the field for Southern Baptists that 5,000 will soon be needed.

University and his M.S. Degree at George Peabody College for Teachers. He came to Gardner-Webb as public relations director in 1954, serving until 1960 when he assumed the editorship of *Charity and Children*, published by the Baptist Children's Home in Thomasville. It has a weekly circulation of 55,000 among N. C. Baptists.

The *Courier* is published in Greenville, S. C., and has a circulation of 80,000. Roberts began duties there on July 1. Dr. S. H. Jones, 65, has been editor of the paper for the past 17 years.

## Boiling Springs Tops Its Goal

Surging past their \$26,000 goal, Boiling Springs area campaign workers boosted Gardner-Webb's campaign for expansion and development beyond the \$900,000 mark.

Area chairman, Jim Beason, saw his organization total \$28,533 for three weeks work and become the first organization in Cleveland County to meet its goal. O. P. Hamrick, '11, was canvass chairman in the drive.

Before the campaign began \$54,130 had come out of the Boiling Springs immediate area and \$2,025 from Mooresboro. This money came from the campus community, advisors of the college, trustees of the college and special gifts persons who were solicited earlier. This puts the Boiling Springs, Mooresboro and Lattimore area on record for \$84,688 given or pledged to the college since the first of January of 1965.

Some of the leaders among hundreds of workers were those on the Mooresboro team of Clyde Goforth, Jr., who collected 20 gifts for \$2,815 and topped all other teams. Mrs. Rachel Huggins Hedrick, '38, of Boiling Springs headed a unit which raised \$2,225. William K. Elliott, '51, of Boiling Springs was division chairman of the workers who raised a high of 72 gifts for \$8,165.

Dr. James Blaine Davis, first president of Gardner-Webb College, had for years dropped out of the history of the school which he headed in 1928-1930.

Search for a portrait of him to be added to those of other presidents led to one of Dr. Davis' sisters, Mrs. Stella Davis Nix of 137 Forest St., Spartanburg, S. C. She graciously secured a picture of Dr. Davis and filled in college personnel on Dr. Davis' activities since leaving the college.

Dr. Davis died at a son's home in Norfolk, Va., three years ago this past June 22. His task was a hard one as he seized the reins of Boiling Springs Junior College in its first two years of transition from high school to college status.

A graduate of Mars Hill College, Wake Forest College, the University of North Carolina and Southwestern Baptist Theological Seminary, Dr. Davis came to the college from a pastorate at Henderson Street Baptist Church of Cleveland, Texas. Earlier he had been an instructor at N. C. State College and in 1919-1923 was an instructor at the Univ. of N. C.

His formal opening speech to 78 college students and 124 special and high school students appears today to be justified as Gardner-Webb enters a new era of expansion and development. Dr. Davis predicted the college would become "the educational center of Piedmont North Carolina."

History points out the hundreds of problems facing the new president. He wrestled with them for two years before resigning May 20, 1930. Dr. Zeno Wall of Shelby became the new president.

A pastorate at Buffalo Creek Baptist Church near Grover came next, followed by a call to a Baptist Church in Norfolk. Bob Jones University in Greenville, S. C., employed Dr. Davis as a professor until ill health forced his retirement. He lived until his death in 1962 with a son, W. J. Davis of 1115 Park Ave., South Norfolk, Virginia.

His other living sisters, other than Mrs. Nix, are Mrs. Flora Davis Riddle of 37 Elmwood Ave., Judson, Greenville, S. C., and Miss Lucy D. Davis of 10 Bobo St., Greer, S. C. James Blaine Davis, Jr. lives

The religious activities chapel, part of the proposed religious activities center for the college will be built in memory of John R. Dover, Jr., who served many years on the Gardner-Webb Board of Trustees and in other capacities of assistance.

As it is now proposed, the chapel will be the center for the religious activities of the campus. Dr. Poston said, "This is a big step toward the building of a visible symbol of the 'Extra Dimension.' We at Gardner-Webb have no center for the religious activities at the present time. The fundamental necessity for offering a strong education program has held priority and some of the gracious aspects of the college have had to be postponed. The time has come, however, to erect a visible symbol of the 'Extra Dimension' and the Religious Activities Chapel will be just

that."

John R. Dover, III, acting on behalf of himself, his sister, Mrs. G. J. Vincent and his mother, presented the gift to the college through Dr. Poston. He remarked that his father had often told him of the many contributions Gardner-Webb College has made to the community and to his own life.

John R. Dover, Jr., attended Boiling Springs High School, forerunner of Gardner-Webb, in 1911 and was part of the school's growth from a high school to a junior college. He was chairman of the committee which selected Dr. Poston president to replace the retiring Dr. Philip Elliott. Dover was active in civic and church life of the community serving in many capacities. Among these was presidency of the Shelby Rotary Club and superintendent of the Dover Baptist Sunday School. He also served as chairman of the board of the Dover Textile Group.

in Florida and Dr. Davis has a brother living in Texas.

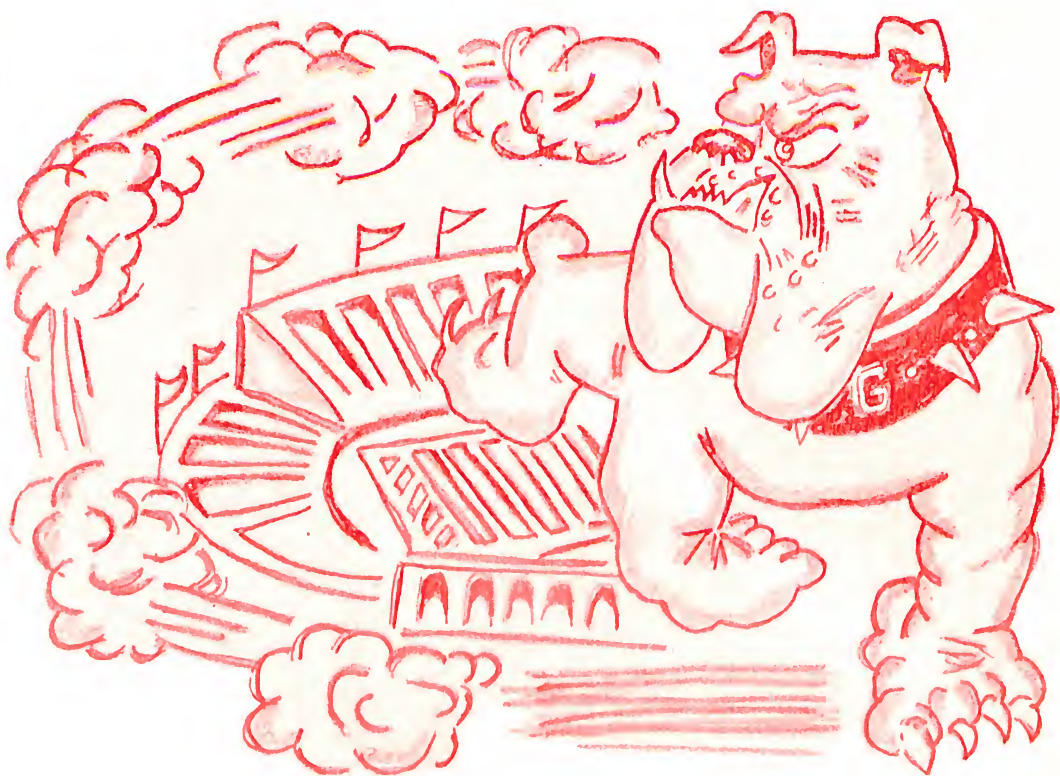
Mrs. Nix writes, "We will appreciate a record of J. B.'s labors as he worked his way through college by teaching mathematics, Bible and Greek. He worked hard

## HOW WILL MY MONEY BE USED?

At this time, we finance our athletic program from two sources: money received from college funds, and money received through donations to the Bulldog Club. The sum of \$5,000 supports our entire financial aid program. One-half, or \$2,500 of the total requirement is raised through Bulldog Club activity. The other one-half of the required amount is supplied by the college.

We give financial assistance to our athletes on an equal basis with regard to amount. Every man who earns a letter in one of the so-called major sports (football, basketball, and baseball) receives a cash award of \$100.00. An athlete earns a letter by playing in one-half of the total quarters, or innings in the respective major sports.

In apportioning our scholarship money among the three major sports, we anticipate that about 25 men will earn a letter in football, 10 in basketball, and 12 in baseball. These awards total \$4,700 of the allocated \$5,000. We allow three \$100.00 grants for sweater awards to those athletes who do not qualify for financial assistance. This \$300.00 also allows us to meet our obligation should more men earn a letter than we had anticipated.

We do not give financial assistance to men who earn their letter in one of the so-called minor sports, track, tennis, and golf.

## Student Center, Covering Of Pool Now Underway

Gardner-Webb College Trustees have let contract for construction of a \$488,425 campus center to be known as the Charles I. Dover Campus Center. In other action, the Trustees let contract of \$61,500 for the covering of the college swimming pool.

The campus center will be located on the former site of the Huggins-Curtis Building which burned in 1957. This building, equipped, architects' fee paid and furniture purchased, will cost a total of \$538,425.

A dining room with a capacity of seating 560 persons at one time, a cafeteria kitchen, snack shop, bookstore, recreation area, post office, faculty offices, publications room, lounge and student government room will be major parts of the building.

The pool will be covered with steel and glass materials with the use of some brick at each end. The ceiling will have thermal skylights and the sides will be made up of sliding glass doors which can be opened for summer use.
