Charlotte Telethon Raises \$1,153 For Alumni Annual Fund

The Gardner-Webb College Alumni Association held its first telethon on Tuesday evening, June 17, 1975 at the J. P. Stevens Office Building in Charlotte, North Carolina. The purpose of the telethon was to solicit pledges to the Annual Fund. Mr. Julius Peckston, Chairman of the telethon and a Director of the Alumni Association, and Mr. Bill J. Briggs, Coordinator of Development, Alumni, and Deferred Giving at Gardner-Webb, directed the telethon which was held from 7:30 until 8:30.

Two alumni from Charlotte and three from Gardner-Webb volunteered to solicit for the telethon. Others helping were Mrs. Marie Tally, Secretary to Mr. Peckston, Mrs. Jane Reynolds, Secretary of the Alumni Association and Alumni Office Secretary, Miss Cindy McGrew, student; Miss Sandy Ledford, student, and Mrs. Van Wootton, student.

The solicitors made 175 calls, of which 209 were incomplete. They received 52 pledges amounting to \$1,153.

Mr. Briggs presented certificates of appreciation to all Charlotte alumni who participated in the telethon. An award for the most dollars solicited went to Mr. Jim Williamson who raised \$240 in pledges. Mr. Charles Christmas also received recognition for the largest number of donors.

The telethon, a very worthwhile project in itself, also gave the alumni the opportunity for fellowship with other alumni solicitors whom they knew and to renew acquaintances with the alumni whom they called.
