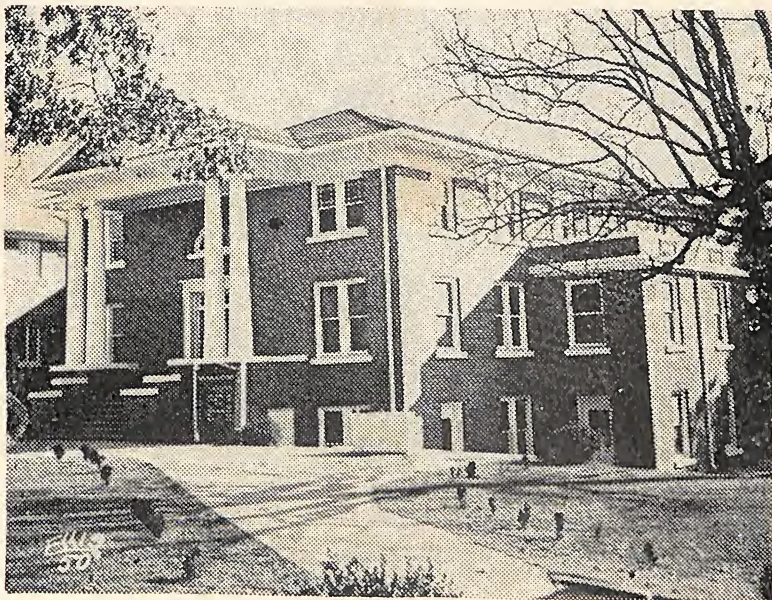

REV. JOHN W. SUTTLE

John W. Suttle has been long recognized as the Dean of Southern Baptist Preachers. He has been Pastor of the Double Springs Baptist Church since 1918. Under his leadership, the present building was erected in 1917, what was then a wonderful church building. This resulted in a period of rapid expansion and improvement for the Kingdom work.

Pastor Suttle was converted at eight years of age and joined the Beaver Dam Baptist Church of which he is a member and pastor. He has been preaching for more than sixty years. Pastor Suttle and the members of the Double Springs Baptist Church entertained the Kings Mountain Association on the first day of the Annual Session of 1950.

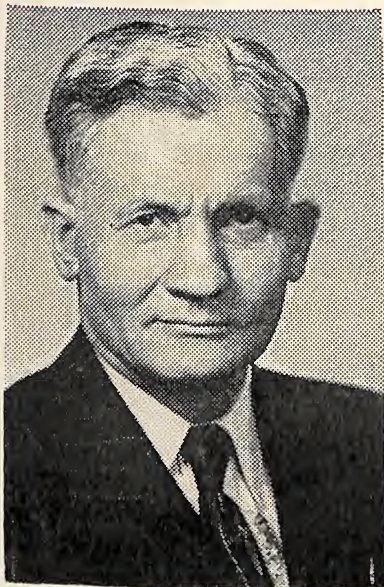


DOUBLE SPRINGS BAPTIST CHURCH

The Double Springs Baptist Church was constituted 1844 (one hundred and six years ago) the Kings Mountain Baptist Association was organized in this church in 1851 with thirteen churches as charter members. It is right that the One Hundredth Annual Session of the Kings Mountain Association should be held with the Double Springs Baptist Church.

Rev. John W. Suttle has been pastor of this church for thirty-two years and moderator of the Kings Mountain Baptist Association for thirty-eight consecutive years. He was elected first, at the Mt. Zion Baptist Church, now a member of the Gaston Association, then a member of the Kings Mountain Association—1912—and for his thirty-ninth time at Double Shoals Baptist Church this year.

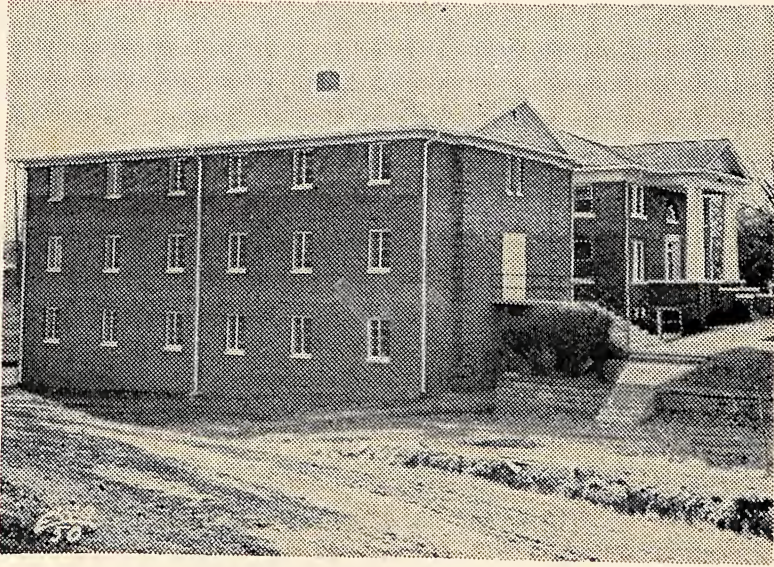
The present membership of the church is 465, the total reported contribution of the church for the Association year was \$12,000.00.



J. N. BARNETTE

J. N. Barnette, one time member of the Double Springs Baptist Church was asked to return to his old home church to deliver the Centennial Message to the One Hundredth Annual Session of the Kings Mountain Baptist Association held with the church. He accepted Christ as his Saviour about fifty years ago and joined the Double Springs Church and served there for many years.

About 25 years ago he was called to work with the Sunday School Board at Nashville, Tennessee. For these years he has been busy helping in the Sunday School work in his own Southland. He is known and loved by the Baptist people of North Carolina and of the Southern Baptist Convention.



THE DOUBLE SPRINGS EDUCATIONAL BUILDING

This new Educational Sunday School Building of the Double Springs Baptist Church was erected and finished in 1950. It is a spacious three story structure beside the present Worship House.

This building has 24 Sunday School rooms, 4 department rooms, wide halls and basement rooms with a heating system for the entire building.

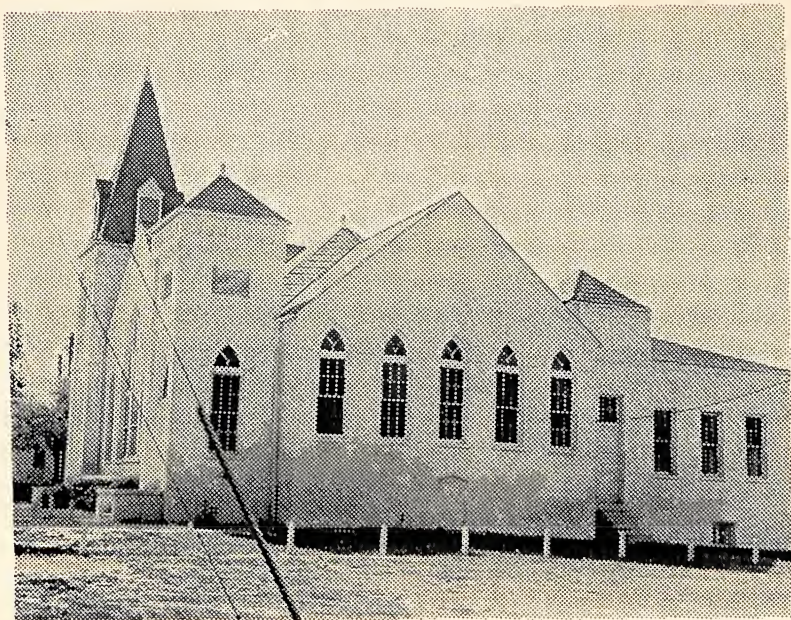

CLERKS NOTE: Only the messengers that signed cards at the Session of the Association are listed above. The visitors who are listed are those that signed visiting cards.

THE CONSTITUTION

Kings Mountain Baptist Association

Adopted—October 21, 1949

PREAMBLE: We, the messengers of Baptist Churches in the County of Cleveland, State of North Carolina, and territory adjacent thereto, do hereby propose to establish and maintain the order and rules of a district Association in conformity to the following plan:

NAME

ARTICLE 1: The name of the organization shall be the Kings Mountain Baptist Association.

MEMBERSHIP

ARTICLE 2: The Association shall be composed of Baptist Churches of Cleveland County and adjacent territory which are now members, and any other Baptist Churches which may thereafter be admitted as herein provided.

ARTICLE 3: Churches applying for membership shall agree, if received, to come under the watch-care of the Association for a period of one year or more at the discretion of the Association. During this period such churches shall be entitled to all rights and privileges of the Association except holding office and voting.

ARTICLE 4: Each church shall elect annually messengers to the appointed meeting of the Association. Such messengers must be duly certified to in the annual church letter to the Association, and appointed on the following ratio: Two messengers, in addition to the pastor, for each church having a membership not exceeding fifty, and one additional messenger for each increase of fifty or major fraction thereof, provided that the total number of messengers shall not exceed ten.

PURPOSE

ARTICLE 5: The prime purpose of this Association shall be to counsel together for the enlargement and strengthening of God's Kingdom and promoting unity and growth among the churches composing it; and by co-operating with the Baptist State Convention and the Southern Baptist Convention and their agencies in the work of Missions, Christian Education, and Social Service.

MEETINGS

ARTICLE 6: The Association shall meet annually on Thursday after the third Sunday in October and continue for two days or longer in the judgment of the Committee on Order of Business, subject to the Approval of the Association. The place of meeting shall be determined at the previous session.

OFFICERS

ARTICLE 7: The officers of the Association shall be a Moderator, Vice Moderator, Clerk-Treasurer, and Historian, all of whom shall be elected annually by the Association at its annual meeting and hold office until their successors are elected.

DUTIES OF OFFICERS

ARTICLE 8: It shall be the duty of the Moderator to, in advance of, the annual meeting, communicate with the host churches requesting that they appoint from their church membership a committee on enrolment; to open the meetings punctually at the appointed time; to appoint a committee on committees in the opening session; to enforce the rules; to preserve order; and to exercise all the prerogatives of a presiding officer according to the principles of established parliamentary usage.

ARTICLE 9: It shall be the duty of the Vice Moderator to discharge the duties of the Moderator in his absence.

ARTICLE 10: It shall be the duty of the Historian to collect and put in some durable form all facts of particular interest about each of the member churches and report at each session of the Association.

ARTICLE 11: It shall be the duty of the Clerk-Treasurer to keep an accurate record of the proceedings of the Association; to superintend the printing and distribution of the minutes; to keep on file the printed minutes and other important documents belonging to the Association; to receive and pay over to the proper parties all the money contributed direct to the Association, and make an annual report to the Association. For his services he shall be paid annually an amount recommended by the Finance Committee and approved by the Association.

COMMITTEES AND THEIR DUTIES

ARTICLE 12: The committees of the Association shall be divided into three categories:

SECTION A. Those appointed in advance of the annual meeting:

1. A Committee on Enrolment appointed as prescribed in Article 8; and any others he may deem advisable or necessary.

SECTION B. Those named to report at the annual meeting at which they were appointed:

1. A Committee on Committees appointed as prescribed in Article 8. It shall be the duties of this committee to appoint, a committee on Place and Preachers for the next session, a Committee on Resolutions, and any other deemed advisable.
2. Committee on Place and Preacher, whose duty shall be to recommend to the Association churches at which the next session shall meet and preachers that will preach at the next session.
3. A Committee on Resolutions whose duties shall be to draw up and present to the Association suitable resolutions of appreciation and expressions of sentiments on any matter chosen by the committee.

SECTION C: Those named by the Association to serve throughout the year who shall report at the next annual session of the Association:

1. A Committee on Order of Business, which shall consist of the Moderator, Vice Moderator, Clerk-Treasurer, Superintendent of Sunday School, Director of the Training Union, and President of the Woman's Missionary Union. It shall be the duty of this committee to report a suggested order of business as soon as feasible after the opening of the Association. When adopted, their report shall become the order of the Association and cannot be changed except by vote of the body.
2. A Committee on Nominations, whose duty it shall be to nominate all officers of the Association (Article 7), a Committee of Trustees, an Auditing Committee, General Officers of the Baptist Training Union, General Officers of the Sunday School, and members of the Associational Missions Council, a Committee on Nominations, a majority of which shall be Laymen, and any other officer, committee, council member, or representative to be elected to serve throughout the year. Nominations by this committee shall not preclude nominations from the floor.
3. A Committee of Trustees, whose duty it shall be to hold in trust any property, money, endowment, or other securities of said Association.
4. An Auditing Committee, whose duty shall be to audit the Clerk-Treasurer's books annually and report annually to the Association.

THE GENERAL BOARD

ARTICLE 13: At each annual session a General Board shall be appointed by the Association, which shall consist of the general officers of the body together with the Superintendent of Sunday School, Director of the Baptist Training Union, The President of the Woman's Missionary Union, President of Gardner-Webb College, Members of the Associational Missions Council, the pastor of each church composing the Association, and two members from each church which members shall be nominated by the church or by delegates present from the church and approved by the Association.

ARTICLE 14: This board shall hold meetings monthly, and shall exercise the functions and discharge the duties usually committed to an executive board or committee. The purpose and plan of this General Board in all its meetings shall be to promote the interest and carry forward the work of the Association and of its constituent churches as this work is outlined in Article 5.

ARTICLE 15: In case of emergency the General Board may select a time and place and arrange for a special business session of the Association; provided that no action taken in such extra sessions of the body shall conflict with any action of a previous regular session, and provided that the business of such extra sessions shall be limited to the object for which it was convened, and the membership of such special business session shall be made up of the messengers elected by the churches and accredited to the previous regular session.

THE MISSIONS COUNCIL

ARTICLE 16: The Association shall elect annually an Associational Mission Council composed of fifteen members, a chairman of which is designated.

ARTICLE 17: Said Council shall meet at least three times annually. The first meeting shall be held within ten days of the Associational meeting at which the council was elected. At the first meeting the council shall divide itself into such committees as seen necessary to provide a well rounded and worthy associational missions program and emphases. It shall have at least the following committees:

A.—Administration and Finance. The chairman of which shall be elected chairman of the council. This committee shall receive monthly reports from the Associational Missionary; advise with him periodically in matters pertaining to his work and activities; make an associational budget to be presented to the association providing for financing the work for the coming year; and to have general oversight of work of the Council.

B.—Missionary Planning. This committee shall survey communities in need of Baptist work and Ministry; seek to enlist churches to sponsor work in such communities; give guidance and assistance in proper

location and organization of new Baptist work; provide information for and make recommendations to the Association as to missionary needs which might be met by co-operative efforts; provide information to the State Mission Board which might be helpful in meeting missionary needs; consult with churches anticipating membership in the Association and making recommendations to the Association in matters of this kind; and leading the Association in a program of meeting such missionary needs.

C.—Institutional and Interracial. This Committee shall seek to enlist churches to have a worthy part in ministry to folks in our public institutions, and to be of service as friend and brother in Christ to people among us of other races.

RULES OF ORDER

RULE 1. The business session of the Association shall be opened and closed with prayer.

RULE 2. All officers shall complete their work as soon as practicable after the closing of the session. The newly elected officers shall assume, at the close of the session, all duties incumbent upon said officers relating to the work of the ensuing Associational year.

RULE 3. Every report, resolution, or amendment offered to the Association shall be submitted in writing if requested by the Moderator.

RULE 4. No person shall speak more than twice on the same subject, except by the permission of the Association.

RULE 5. Messengers present from one third of the churches shall constitute a forum.

RULE 6. All questions shall be decided by majority vote of the members present except changes in the constitution, which shall require two thirds vote of those present. Proposed changes must be presented to the Association the first day it is in session and voted on the second day.

RULE 7. All questions of order not herein provided for shall be decided by general parliamentary law by Kerfoot.

CONFESSIONS OF FAITH

1. We believe the Scripture of the Old and New Testaments to be a divinely inspired revelation from God.

2. We accept the New Testament alone as revealing the only plan of salvation and as the final authority in all matters of church policy and practice.

3. We believe Jesus Christ as revealed in the New Testament to be the Son of God and the divine Savior of all who truly accept Him as such.

4. We believe in the personality of the Holy Spirit, and in His abiding presence with the spirit of all the elect of God, in His quickening presence with the spirit of the unregenerate moving to repentance and faith, in His witnessing presence with the spirit of the regenerate comforting and guidance throughout life in His sustaining presence in the experience of death, and in His continuing presence in the life to come.

5. We believe salvation is attained through spiritual regeneration in the act of repentance and acceptance of Jesus as Savior.

6. Sincere spiritual redemption was made available by the death, burial and resurrection of Jesus, we believe that every regenerate person should symbolize his own salvation by being buried with Him in baptism.

7. We believe that a local church modeled after the New Testament order is a company of regenerate persons voluntarily joined together for the purpose of extending God's Kingdom on earth.

8. We believe that each church should from time to time, as a congregation, celebrate the Lord's Supper as a memorial to Him.

9. We believe in the ultimate triumph of God's Kingdom over all opposing powers, and that every regenerate soul shall have a share in that triumph.

5—The order of Business: The Chairman of the program committee, C. O. Green, Vice Moderator, presented the following as the order of business: A motion to accept was made and passed.

6—New Churches: Ben's Baptist Church—South of Kings Mountain off Highway No. 29—Westover Baptist Church, West Kings Mountain off Highway No. 74—King's Chapel, Churchill Drive, Shelby. The messengers were introduced and a motion was made by Lawrence Roberts, Chairman of the Missions Planning Committee: that these churches be received under the watchcare for one year. These churches were received by vote of the Body.

7—New Pastors: the new pastors were welcomed into the fellowship

of the Association, fifteen in number, they are listed with the Reports and indexed.

8—The moderator recognized C. O. Greene at this time. He had in his hand a new gavel made from a piece of wood taken from the home place of Joe Suttle, grandfather of J. W. Suttle. Joe Suttle was pastor of the Double Springs when the association was organized in 1851. J. W. Suttle, the present pastor of Double Springs Church received the gavel as his own personal property upon motion by C. O. Greene and passed by the Association.

9—This Centennial Session—An introduction by Pastor J. W. Suttle also—moderator of the Association. He spoke of the first years of the century. His Reminiscence 1. Our forefathers wrought well. He spoke of the new Educational Building, of the Historic Relics placed there to be seen, the picture of Thomas Dixon, first moderator, A. C. Irvin, Judge E. Y. Webb and J. W. Suttle. Webb and Suttle, the only two living moderators. The moderator welcomed the visitors at this time. Their names are to be found above.

10—Cooperative Program—Written report read by Smoot Baker, pastor First Baptist Church, Grover. There was a motion to adopt the report and after discussion by M. A. Huggins, Secretary of the North Carolina State Convention, the report was adopted. The topic of Secretary Huggin's discussion was "The Glorious Past; the Bright Future."

11—At this time Moderator Suttle appointed the committee on Committees: Hugh Harrill, Chairman, G. P. Irvin, E. D. Humphries, C. R. Spangler and C. S. Elliotte.

12—Song: "Majestic Sweetness Sits Enthroned," by quartette of Double Springs Church: Misses Mary Willie Crowder, Jorene McSwain, Jo Carol Jones, and Linda McSwain. Gardner-Webb College Glee Club sang two numbers—"Jesus Saviour Friend of Mine" and "Open Mine Eyes."

13—Christian Education: Written report by Phil L. Elliott, president of Gardner-Webb College was read and adopted after President Carlyle Campbell of Meredith College, Raleigh, North Carolina spoke on the theme "The Past and Future of Christian Education."

14—At this time the moderator recognized Judge E. Y. Webb, former moderator (time of service 1897-1901) and United States Senator Clyde R. Hoey.

15—Song: "My Faith Looks Up To Thee" the congregation standing.

16—C. O. Green, Chairman of the Centennial Committee presented the following recommendation: Because of the down pour of rain, we recommend that the pageant be presented at the E. B. Hamrick Auditorium, Gardner-Webb College tonight instead of here in the church yard. So adopted.

17—The Centennial Message: J. N. Barnette, from the Sunday School Board of Nashville, Tennessee and one time member of the Double

Springs Baptist Church spoke on the "Hundred Years Work of the Association"—and emphasized the need for us to do a greater work. His Text: John 15:8—Matt. 7:6 "Ye shall know them by their fruits." "That ye bear much fruit." "This Thy Day." Luke 19:42.

18—Song: "Praise God From Whom All Blessings Flow" prayer by Zeno Wall, Shelby, North Carolina.

19—Lunch served by the Double Springs women in the basement of the church because of the heavy rain.

THE AFTERNOON SESSION

20—The afternoon session was called to order by moderator at two P.M. Song: "My Jesus I Love Thee." Roland Leath leading and Mrs. E. T. Bailey at the organ.

21—Worship: Archie Hughes, pastor of Carpenters Grove Baptist Church, read the Scripture Lesson: James 1:1-20; I John 5:3. He led the prayer.

22—Business: (a) The Treasurer report was presented by the Clerk-Treasurer—as information. (b) The Committee on Committees made the following report: Time and place, preachers—Committee: J. D. Elliott, Chairman, Mrs. N. B. Lee, and G. T. Cabaniss. Resolutions Committee: Mrs. L. H. Ledford, Roland Leath and R. L. Nichols. (c) W. W. Harris, Chairman of Finance introduced the recommendation from the General Board that an offering be made to defray the expenses of the pageant being presented by Gardner-Webb College. Subscriptions were made by the pastors and messengers of the churches to the amount of \$420.00. (d) The report of the Auditing Committee to audit the Books of the Clerk-Treasurer, was read by W. W. Harris at this time and was accepted by the association.

23—Woman's Missionary Union Report: Mrs. B. A. Harry, Sr., Superintendent of the Woman's Missionary Union of the Kings Mountain Association read the report. Upon motion to adopt the report Mrs. B. A. Harry introduced to the association Mrs. Foy J. Farmer, president of the State Woman's Missionary Union. She introduced Mrs. John W. Wacaster the State District State Worker—who also spoke to the report. Mrs. Farmer's theme was "A Glorious Past—A Hopeful Future." At this time Mrs. B. A. Harry presented Mrs. Frank Elam to the Association the mother of Mrs. W. P. Biggerstaff; Mrs. Biggerstaff served as Superintendent of Woman's Missionary Union for five years. Before that Mrs. John W. Wacaster served as Superintendent for twenty-five years.

24—The Sunday School Work: Written report prepared and read by J. R. Howe, pastor of Highland Baptist Church, Shelby. It was adopted after discussion. J. N. Barnette spoke on the "Past and Future of Sunday School Work." Does the Sunday School Work Pay? Is Sunday School work worth while?

25—The Baptist Orphanage: On motion the report was not read because of the absence of the writer—J. R. Hullender—Zeno Wall, former superintendent of the Orphanage spoke to the report on the subject "A Great History and a Great Future." He introduced Mr. and Mrs. R. E. Muth, Treasurer of the orphanage; also, Miss Kate Roberts, House mother of Bigg Cottage.

26—The following Announcements: C. O. Greene, pastor of Double Shoals Baptist Church, gave invitation to come to Double Shoals tomorrow. Moderator emphasized the pageant to be presented at Gardner-Webb College at 7:30 o'clock and for everyone to attend. W. W. Harris led in the singing of the Doxology—adjourned to meet at Gardner-Webb College at 7:30 o'clock.

THE THURSDAY NIGHT SESSION

27—The messengers and visitors gathered in the E. B. Hamrick Auditorium to view the presentation of the Historical Pageant. With J. W. Suttle presiding; the song, "Onward Christian Soldiers" was sung by the congregation, standing. W. W. Harris, pastor of the Second Baptist Church led the song. Miss Dorothy Jones of Boiling Springs Church played the organ. Prayer was spoken by E. B. Hicks, pastor of the Eastside Baptist Church, Shelby, N. C.

28—Moderator Suttle at this time recognized Ben C. Fisher of Gardner-Webb College and Director of the Historical Pageant Committee. He gave words of welcome and appreciation for the interest and help in the preparation of the pageant.

29—Phil L. Elliott, president of the college gave words of welcome and appreciation for the work of J. W. Suttle with and for the college. A standing vote of thanks and appreciation was made by the congregation to the college and friends for the presentation of the Historical Pageant.

30—Historical Pageant: By Gardner-Webb Dramatics Department—A Dramatic Narrative of Baptist progress—produced by Gardner-Webb College Public Relations Department, Ben C. Fisher, Director. Peaks within one hundred years of Christian growth—told in words and music and pantomime.

31—Closing song: "I Am Bound for the Promised Land." Prayer—J. W. Suttle.

SECOND DAY SESSION

32—Song: "He Leadeth Me" Roland Leath leading—Miss Fay Wilson at the organ and Mrs. E. T. Bailey at the piano. J. W. Suttle presiding.

33—Worship: W. L. McSwain, Pastor of David and Allen Memorial

Baptist Churches, read the following Scriptures: Psalm 23; Matt 1:18-25; Matt. 16:13-20; Rev. 1:12-20. Theme: "God is present with His people." Matt. 1:21 "Thou Shall call His name Jesus." "God with us." "Emmanuel." Prayer.

34—Business (a) Announcements all messengers shall register. W. W. Harris ask that everyone that will to sign the Freedom Scroll. (b) By motion and adoption the Clerk was instructed to print the picture of J. N. Barnette in the minutes and that Double Springs Church would pay for the page. (c) Visitors introduced.

35—Christian Literature: Written report by C. M. King, member of First Baptist Church, Shelby, N. C. read the report. C. W. Bazemore, Representative of the Biblical Recorder, Raleigh, North Carolina, spoke to the report on the topic: "Christian Literature in Baptist History." The report adopted.

36—Song—"Amazing Grace" congregation standing.

37—Baptist Hospital: Written report to be written and presented later. Motion to adopt that J. R. Dover is to report later. E. M. Smith, Richard K. Young, Chaplain of the Baptist Hospital spoke on the theme: "The Ministry of Healing."

38—Public Morals and Civic Righteousness: Written report by Hugh Harrill, pastor of Sandy Plains Baptist Church. Address: "Some Accomplishments—the Work Ahead," by Judge E. Y. Webb of First Baptist Church, Shelby, North Carolina. Report adopted.

39—(a) Song: "Breathe On Me," by congregation while standing. (b) Announcements by pastor, C. O. Greene as to the lunch hour and the meal.

40—Doctrinal Sermon: Scripture Lesson read by Lawrence Roberts, Pastor of Pleasant Hill, and Putnam Memorial Baptist Churches. Prayer was given by H. E. Waldrop of Shelby, North Carolina. Scripture: Acts 12:5. The Doctrinal Sermon on "Prayer" was preached by Lawrence Roberts, Clerk. Closing prayer by the speaker, and the noon recess. Adjourn for lunch.

THE FRIDAY AFTERNOON SESSION

41—Song "Higher Ground" was sung. C. O. Greene, Vice Moderator, presiding in the absence of J. W. Suttle.

42—Worship: C. C. Crow, pastor of Mt. Sinai and Oak Grove Baptist Churches, read the Scripture Lesson from Psalms 78:1-6 and 35. Theme "Thanks to those who lived in the past." What shall we do with it? Our heritage? "The challenge—We shall do our part." He led the association in prayer.

43—The Digest of the years' work: Report of the General Board to the Association read by the clerk. A motion to adopt after discussion the report was adopted as read.

44—A motion was made to give an expression of appreciation to T. C. Holland and to O. M. Mull for the gift of lots. This was done by a standing vote of thanks.

45—Report on Associational Missions: The report of the Mission Council was read by W. W. Harris, Chairman: A motion was made to adopt the report—after discussion by E. M. Smith, Harlan Harris, Lawrence Roberts the report was adopted. In adopting the report, a new missionary was called to work with us. Tom W. Bray who is now missionary in the Rowan Association.

46—Ministering by Radio: Report read by Harlan Harris, pastor of the First Baptist Church, Shelby, N. C. First, he stressed the need for the churches to establish a charity fund in the local church to help the needy in the community. Second, he asked that the churches take part in the Christmas parade in Shelby and make the parade Christian, portraying the nativity scene. He then read the Report of Ministering by Radio. The report was adopted.

47—Song—"At the Cross" was sung—congregation standing.

48—American Bible Society: Report read by W. F. Monroe, pastor of the Temple Baptist Church of Kings Mountain, North Carolina—a motion to adopt was made. He spoke to the report. It was then adopted.

49—In behalf of a Distressed World. (Relief): Written report. It was read by E. M. Smith, pastor of the Dover Baptist Church, Dover Mill, Shelby, N. C. He discussed the report and the need for relief of a stricken world. The report adopted.

50—The Election of Officers and Report of Committees came at this time.

(1) The standing nominating committee made its report—nominating the officers and members of the committees. Walter Davis, Chairman of the Committee and member of the Zion Baptist Church read the report. The report adopted and the named were elected to fill the several places. The list will be found in the section of reports. (2) Several motions were made at this time to change the constitution, but the presiding officer, C. O. Greene, ruled them out of order. (3) Time, place, and preachers committee made its report at this time:

The report adopted. (4) Mrs. L. H. Ledford, Chairman of the Resolutions Committee made its report. It was adopted by the Association. The report will be found below.

51—Memorials: By Wilbur Wilson, member of the First Baptist Church, Shelby, read the names of the Beloved departed Dead of the churches. The people stood while the names were being read, and the prayer was offered.

52—Business: (1) On motion, that the Secretary Treasurer be a member of the Mission Council at all times. The motion second and passed by the vote of the body. (2) The announcement by Mrs. Smoot Baker of the meeting at Grover First Church tonight. She called for the Training Union members to be there as well as the pastors and deacons. J. W. Suttle also stressed the need for the messengers to attend the closing night of the sessions of the Association.

53—Song "On Jordans Stormy Banks" was sung by the congregation as it stood. The first stanza was sung.

54—Inspirational Message: By G. C. Teague, pastor of the Patterson Grove and Union Baptist Churches. He read the following Scripture Lesson: Exodus 14:13-16. Zeno Wall was asked to offer the prayer. The Theme of G. C. Teague's message was "Go Forward" which was also the text. "Go forward in 'Evangelism—Enlistment, Teaching, Training and Cooperation'—Reasons for going forward—Cannot go back; nor stand still, to live we must go on."

55—Song: "Onward Christian Soldiers." Prayer by moderator J. W. Suttle. Adjourn to meet with the Grover First Church for the night session.

NIGHT SESSION

56—The night session met with Grover First Baptist Church, Grover, N. C., at 7 o'clock. Moderator Suttle called the meeting to order. Song: "I Am Thine, O Lord" was sung by those assembled. Prayer was offered by John S. Farrar, the new Pastor of the New Hope Baptist Church.

57—Business: (1) Walter Davis, layman from the Zion Baptist Church made the following motion: that the association pay the Clerk-Treasurer \$500.00 for his work. The motion was seconded by G. C. Teague, pastor of Union Church. The motion was accepted and passed by vote of the messengers. (2) Another motion was made and passed: That the Clerk be authorized to prepare the minutes for the publishers, have them printed and distributed to the churches.

58—Devotional: Was in charge of L. T. Hamrick, Layman and member of the First Baptist Church, Shelby, N. C. He read for the Scripture Lesson I Timothy 2:15. Text. Subject: "READ the BIBLE." To Know, To Glow, To Go. He led the prayer.

59—Reviewing Baptist Training Union Work, by Mrs. Smoot Baker, Director of the Baptist Training Union of the Kings Mountain Baptist Association. She read the report.

Mrs. Baker (1) Enrolled the people present—345. (2) Introduced the Associational Training Union Officers. (3) Used adults on the program from: Patterson Grove, Poplar Springs, Pleasant Hill and Highland Churches. She stressed a place for every member of the family in the Baptist Training Union of the churches. (4) The Youth Choir assembled from the churches—sang—"Arise, O Youth of God."

60—Mrs. Baker introduced to the assembly, Harvey Gibson, Baptist Training Union State Director from Raleigh, North Carolina. He discussed the topic: "The Training Union Looks Ahead." Stressed the need to reach more people through the Training Union. Some goals for North Carolina. A motion was made to adopt Mrs. Bakers report. It was adopted by vote of the body.

61—The Eastside and Bethel churches tied for the greatest number in attendance from the Training Unions of the churches.

62—The Baptist Brotherhood Movement—F. O. Champion, president in charge—He did not have a written report. On motion. He was asked to write a report and send to the clerk and such report to be printed in the minutes. So ordered by vote of the messengers.

Horace Easom, who was to have spoken to the report was absent, but sent one to speak to the report. M. O. Thorneburg, member of the First Baptist Church, Gastonia, North Carolina, Deacon, Vice-President of the Brotherhood of North Carolina and Secretary of the Grover-Thread Company spoke on the theme: "The Challenge of the Future"—"The Layman and his Church." J. W. Suttle introduced the speaker.

63—Song. "Rise Up, O Men of God." This is the Brotherhood song.

64—J. W. Suttle, moderator of the Kings Mountain Baptist Association, closing thirty-eight years as moderator and elected to lead another year, spoke at length on "The Great Opportunity of the Churches to Honor Christ Through the Churches in Cooperative Effort—What a Great Saviour He Is!"

65—Announcement and invitation by Lawrence Roberts, pastor of Pleasant Hill Baptist Church. to come to Pleasant Hill the first day of the 1951 session.

66—A motion was made to adjourn to meet with the Pleasant Hill Baptist Church for the first session on Thursday after the third Sunday in October 1951.

67—The closing prayer was offered by T. L. Cashwell, Jr., new pastor of the First Baptist Church of Kings Mountain, N. C.

68—The Hundredth Annual Session of the Kings Mountain Baptist Association adjourned after having held its sessions with Double Springs, Gardner-Webb College, E. B. Hamrick Auditorium, Double Shoals and

First Church Grover to meet with Pleasant Hill, Temple Kings Mountain and Poplar Springs Baptist Churches.

PROVIDING THE BIBLE FOR MISSION WORK IS AN ESSENTIAL MISSIONARY TASK.

If the people of the world are to know Christ, they must have the Bible. It is the one primary source of knowledge of Him. The Bible is the missionary's chief tool. The Bible itself is a missionary. It can go where the human missionary cannot go, stay when he must leave, and keep on working in a man's heart.

Every man must have the Bible in his own native tongue if the Word of God is to speak to his heart. Someone must translate it into his language, publish it and send it to him, wherever he may live.

In most countries of the world, the income of the people is so low that they cannot afford even the bare cost of the printed Scriptures. Someone must help those who can pay only a part of the cost and the many who cannot pay at all.

The American Bible Society, a missionary non-profit organization supported by gifts, serves as that "Someone." It aids in Bible translation, publishes the Scriptures without note or comment, and distributes them, without profit and usually below cost, for use in mission work around the world.

DURING 1949 THE AMERICAN BIBLE SOCIETY—

distributed through its own work, at home and abroad, nearly 9 million volumes of Scriptures. Another 2 million volumes were produced through gifts of materials and money to Bible Societies of other countries, especially Germany and Japan, bringing the grand total to nearly 11 million volumes for the year.

In its World Emergency Program, reached a total of more than 25 million volumes of Scriptures in 9½ years, distributed to service men, prisoners of war, displaced persons and civilian populations in Europe and Asia.

These little books, attractive and stimulating to read, are priced at \$15.00 a thousand, which is below cost, but in order to catch the attention and to challenge the Christian people of Virginia to spread the Gospel to every person in the community we are offering to give ½ of all the Gospels they will distribute in lots of 500.

This offer is confined to lots of 500 in order that a church might be stimulated to reach those in the community outside of its own membership and its own Church School.

With the promises of God for His blessings on those who will read, we ask your cooperation in this campaign in Virginia for the balance of this year, 1950.

Next year this offer will be made in North Carolina.

**POINTERS TO HIGHLIGHT IN REPORT TO
BAPTIST ASSOCIATION**

The supply of Scriptures on a non-profit basis in some 200 different languages needed each year by American missionaries at home and abroad is a fundamental necessity in the world mission program of the churches.

To enable your missionary dollar to reach more persons with the Scriptures the American Bible Society prices its Scriptures at or below cost. This is a part of its missionary service.

As one great church leader has said: "It is no exaggeration to say that the offering which you make to the American Bible Society will double the evangelistic value of the dollars which you contribute to the missionary program of the Church. . . A church without Bibles would be as helpless as an army without guns. . . ."

SOME RESOLUTIONS FOR ADOPTION:

(1) That this Association recommends to the local churches the presenting of pocket Testaments to those called to military service as being an effective and a most appreciated "Tie that binds" these men to the Church.

We are glad to report that your Organization has been very active during the year. Four Associational Brotherhood meetings have been held. Many visits have been made to various churches in the Association to assist in organizing Brotherhoods.

Thus far the following Churches have Brotherhoods: Beaver Dam; David; Double Shoals; Double Springs; Kings Mountain, First; Lawndale; New Bethel; Pleasant Ridge; Shelby, First; Shelby, Second; Shelby, Calvary; Shelby, Dover; Shelby, Eastside; and Zion. These fourteen Brotherhoods have enrolled approximately six hundred and eighty-five men. They have been holding regular meetings during the year and have accomplished great things through their own local Churches in advancing Christ's Kingdom. Many special projects have been accomplished by our Brotherhoods.

As for the future we are happy to report that we have several engagements to organize Brotherhoods in our Churches. Much assistance has been given already in the way of information and literature. We confidently expect the time to come in the near future when every Church in the Association will have a Baptist Brotherhood and a new challenge and inspiration will come to our men in advancing the Kingdom of Christ through this great Men's Movement. The future for the development of this new phase of our work was never brighter or more promising.

REPORT OF CHRISTIAN EDUCATION

North Carolina Baptists have a great and challenging program, not the least of which is its Christian schools. Our program of Christian Education is basic to our work. None of our work could advance without our schools to train leadership. Our orphanages, hospitals, assemblies, and all our other State Mission work would die were it not for the fact of trained leadership constantly developing.

Not only are our schools basic to all our work, but they accomplish more on less perhaps than any other agency. There is no attempt here at comparison of the relative values of different phases of our work. We have merely allowed a program to develop in which there is wide discrimination in the pay received by workers. Our teachers, especially in our junior colleges, are the poorest paid employees of our denomination. This ought not to be. In our other work, particularly our hospitals and our assemblies we provide the plant and also the operating expenses. It is not so with the schools.

With such a program we are in grave danger of losing our schools. Forty years ago the Baptists had at least fourteen schools in North Carolina, four senior colleges and ten high schools. Now we have seven. When the State started the development of high schools, ours died. Now the State is starting a system of junior colleges. The government of the U. S. is proposing through the report of its Commission on Higher Education to provide free education to every boy and girl through the junior college level.

I quote from pages 46-47 of vol. VI of that report—"The Commission is also aware of the fact that its proposals for a great expansion of higher education in publicly controlled institutions may make it extremely difficult for many private institutions to survive. A system of tuition-free education up through the fourteenth year and relatively low fees above the fourteenth year and in graduate and professional schools of publicly controlled institutions will undoubtedly force many of the weaker private schools out of existence and profoundly affect the whole pattern of private institutional support. Furthermore, the strengthening of publicly supported institutions, as recommended

by this Commission, may have the effect of further increasing the gradual upward trend in the flow of private benefactions to State institutions."

Coupling these things together it is not difficult to see that instead of retrenching, we shall either come to the rescue of our colleges, see that they have funds to pay the teachers comparable salaries to other denominational workers, and give them the means to provide equipment in keeping with the work they have to do, or we shall close their doors.

Our first thought in regard to Christian Literature should be the Holy Bible. Our first loyalty, our first concern is the better understanding and more complete application of the teachings of the Bible.

The purpose of our whole denomination is the putting into operation and practice the ideals and teachings set forth in the Bible. In order to better accomplish this we have many auxiliary helps in the form of our publications, such as, the Biblical Recorder, Charity and Children, and the numerous publications of our Southern Baptist Boards. There is no scarcity of good Christian Literature. There is a serious question in our minds as to the effectiveness of its use. Every Christian should feel heavily the responsibility of getting the available Christian Literature put to its proper use. Every pastor, Sunday School Teacher, every worker in the church should work with increased zeal and determination to impress on young people the importance of good Literature.

This militant approach is necessary for two reasons: first, our whole society today is filled with mass **unwholesomeness** so far as literature is concerned. This type of literature is available on every turn—it is designed to appeal to the young. Second, we need the **stabilizing** and **satisfying** effects of good Christian Literature to counter-balance the restlessness and uneasiness of our age. People need a message that has meaning.

It is our recommendation that the churches of our Association take renewed steps to see that the available Christian Literature become a more vital part of our Christian experience.

The General Board of the Kings Mountain Baptist Association has met each month during the year to promote the work of the Association. There has come before the Board many important matters to be promoted for the advancement of the work in the Churches.

The General Board approved a loan to the Putnam Memorial Baptist Church for \$400.00 to build a temporary building. The loan to be made for the Portable Building Fund and to be returned to the same fund.

The following requests were approved to the General Board of the North Carolina State Convention for aid on Pastor's salary: Allen Memorial, \$650.00; Plains View, \$480.00; Putnam Memorial, \$480.00. Also an application for aid on Association Missionary Salary to the amount of \$375.00 for the year was approved.

During the week of November 27 to December 2 there was held an Associational Baptist Training Union Study Clinic at the First Baptist Church in Shelby and was well attended. A Sunday School Associational Clinic was held the week of April 2 through 7th at the First Baptist Church of Shelby, N. C.

Mr. W. P. Biggerstaff, Chairman of the Centennial Committee, recommended that the following be added to the Centennial Committee: Mr. Ben C. Fisher, Mr. A. L. Calton, Mr. C. C. Padgett, and Mr. Ray Lowery. These were elected to serve on this Committee.

Mr. F. O. Champion, Chairman President of the Brotherhood, presented the following to serve as officers in the Brotherhood: Program Vice President, Robert Morgan; Attendance Vice President, Ollie Harris; Promotion Vice President, Walter Fanning; Chorister, J. C. Jolley; Secretary-Treasurer, Clifford Hughes and on the Advisory Council; W. W. Harris, Harold Roberts, E. M. Smith and Raymond Jones.

During the year two parcels of land were donated to the Trustees for the Association. O. M. Mull gave a lot in the Eastside Community on Buffalo street for the Missionary Parsonage. Rev. T. C. Holland gave a number of lots in west Shelby between Marion and Warren streets for Church purposes.

The Building Committee appointed at the General Session of the Association last October and instructed to build a parsonage for our Missionary, constructing the building on the lot donated and located on Buffalo street in Shelby. It became necessary to borrow money to finish the house. The General Board instructed the Finance Committee to borrow the money from the Cleveland Building and Loan Association the sum of Nine Thousand Dollars (\$9,000.00). The payment of this loan is Ninety Dollars (\$90.00). The General Board authorized the Treasurer to pay from the General Fund the amount necessary to meet the difference \$9,000.00 and \$2,000.00 which is \$493.83—and to make payment each month.

When the Baptist Hospital Board made request that the State Board approve the acceptance of \$700,000.00 from the Medical Commission of N. C., there was a protest from many of the Baptists of the State, which called for the meeting of the State Convention in Charlotte, N. C., April 27. The Convention voted not to receive the Federal Aid and to raise the \$700,000.00 in two offerings in the Churches the last Sunday in June and September. Therefore, the Moderator of the General Board called for a special meeting of the Association to discuss plans for these offerings. A committee was appointed: J. R. Cantrell,

- (4) If missionary is called on to supply for the pastor while he is away for a revival, vacation, or similar matters, Missionary is to be paid regular supply amount which in turn is to be turned into the Association Mission Treasury.
- (5) If Missionary is called on to supply for the pastor while he is sick, or if he renders such service while the pastor is present he is not to be paid inasmuch as this would be part of his regular work.
- (6) The Missionary shall have two week's paid vacation.
- (7) The Association Treasurer's Books closing date shall be September 30.
- (8) Inasmuch as we do not have a Missionary at the present time, we will not have the Deacon's School as planned for November 20-24.

REPORT OF NORTH CAROLINA BAPTIST HOSPITAL 1950

Our Baptist Hospital has become a haven of hope for thousands of sick persons each year throughout North Carolina. It provides the highest type of medical service for the sick of all classes. It is our means of carrying on the healing ministry of Jesus.

Last year 9,700 patients were cared for in the Hospital and 90,000 visits were made to the clinics for examinations and treatments. About half of these were persons with little or no money; they were provided free professional care by the doctors, and were given additional financial assistance with the cost of the service they received.

This free service was provided largely by our Mother's Day offerings which amounted to \$128,900.00. Other assistance came from various health and welfare agencies, the Duke Endowment, and individual gifts. All this added together enabled the Hospital to provide free service amounting to \$312,500.00, in addition to the work of the doctors. And yet, many could not be given as much financial assistance as they needed because the Hospital did not have sufficient funds.

We are happy to report that at this date the Mother's Day offerings this year are running ahead of those last year. The reports from the special offerings to raise \$700,000.00 toward the building of the new South Wing to the Hospital are most encouraging. It looks now as if the full amount will be raised when all the churches have made their offerings and sent in the money. The 150 new beds this enlargement will provide will relieve the great shortage and enable the Hospital to admit the sick more promptly.

The School of Nursing is admitting one of the largest classes in its history and it looks as if it will be one of the best. It has applications from far more than it can accommodate. The Medical School has likewise had one of its best years.

The Department of Religion is growing and becoming more effective as a part of the life and work of the Hospital. Through the generous support of a friend another Chaplain is being added to the staff. The Department of Religion seeks through its ministry to help make the Baptist Hospital a genuinely Christian institution of healing and teaching.

We are proud to report that the Mother's Day Offering for our Association this year amounted to \$4,409.06 which is an increase over our contributions last year. Perhaps it should also be said that we have already raised above \$10,000.00 on our goal of \$28,000.00 to help build the new wing to our hospital.

May we give our best as individuals and churches to this most worthy enterprise of healing. Realizing always that as Jesus was interested in the healing of men's bodies so should we as Christians and churches be interested.

MINISTERING BY RADIO

The radio ministry affords the pastors of our association an opportunity to reach into the homes of those unable to attend regular worship services. At present we have one fifteen minute program per day, at the 10:15 to 10:30 hour, given to the ministerial association for all denominations.

It might be well to mention supplementary broadcasts that are being made. The first Sunday and the alternate fifth Sunday are given to the First Baptist Church of Shelby by our local radio station, and every Sunday evening the broadcast of the evening service of the First Baptist Church goes out over WOHS-FM. Radio facilities at Gardner-Webb College for special training in radio have been in use for over a year. This past year they were engaged in a half-hour broadcast over the local station, the program being re-broadcast over the Forest City station. The Gardner-Webb choir has had occasion to sing at various times over the Mount Mitchell station, and a wonderful response to their ministry of music resulted.

In addition to local enterprises, we are encouraging the membership of our association to tune in to the regular Baptist Hour which is presented by our Southern Baptist Convention over many nearby stations. It can be heard on Sunday afternoon over the following stations: WGNC Gastonia 1450 Kc. at 4:30; WHKY Hickory 1290 Kc. at 3:30; WJRI Lenoir 1340 Kc. at 3:00 p.m.

We urge that all pastors, Sunday school superintendents, Training Union directors make known to our church constituency the hour and day and location of these broadcasts.

In our convention meeting in Chicago it was voted by almost unanimous vote that the Baptist Hour be a special object of southwide giving, and so in accordance with the motion made and passed, we want to go on record as supporting such a move by our contributions.

REPORT OF THE ASSOCIATIONAL MISSIONS COUNCIL

The Missions Council is happy to report that it has at least made an effort toward carrying out the duties assigned to it by the Association. Pursuant to the requirements of the new constitution, the Council held three meetings during the year at which time each committee met to consider its own particular work and then presented a report to the total group of work done, along with plans and policies for the future. From these meetings regularly called for, and from other special meetings called by the different committees for specific matters, the missionary work of the Association has been planned and carried out.

The work of the finance and administration committees of the council has dealt largely with the matter of supervising the work of the Associational Missionary and promoting the finances of the association. Throughout the year, at the request of the Missionary, counsel has been given to him regarding his work. The committee worked with him in planning and promoting the recent Christian Life Revival which so greatly blessed our churches which participated. Much thought and effort has been put forth regarding the financial program. Soon after the meeting of the Association last year, the committee sent a message to all pastors and treasurers urging them to support the Mission Program by sending in the recommended amount adopted by the Association regularly. At the end of every quarter a treasurer's report, along with a report of the gifts from the different churches was sent to all pastors and church treasurers. Besides being responsible for reporting and urging the support of the churches to the Associational Missions Program, the budget for the coming Associational year was studied and suggested by the committee. It likewise has had to study and make recommendation concerning the financing of the Centennial meeting, the printing of the Centennial Program, and the liquidation of the loan of the missionary's home. These recommendations are a part of the report of the General Board of the Association.

The Activities Committee of the Council has wrought well and worthily during the year. The tent belonging to the Association and under the supervision of this committee was used to good advantage. It was used by the newly organized Putnam Memorial Church during October and November of 1949. The Second Baptist Church of Kings Mountain used the tent for three weeks in June for a revival in East Kings Mountain on York Road. The Second Baptist Church of Shelby used the tent for eight days for a revival in the Lily Mill village in Shelby in August. Zoar Baptist Church, working with Mt. Sinai and New Hope Churches, secured the tent for a revival south of Shelby on Highway 18. For several weeks now the First Baptist Church of Shelby has been using the tent for Sunday School and worship services at a location on Churchill Drive.

The Activities Committee has helped in the organization of several churches during the year. These are Ben's Baptist Church, south of Kings Mountain off route 29, March 26, 1950; Westover Baptist Church, Kings Mountain on September 10, 1950, and King's Chapel Baptist Church in the King's Road Section of Shelby, October 8, 1950. They also helped in locating and securing lots for Westover and King's Chapel. We pause here to express gratitude to O. M. Mull for donating a lot upon which to erect the missionary's home, and to T. C. Holland for donating lots in West Shelby for church purposes.

As a matter of forecasting its work for the new year, the Activities Committee states that in their judgment the following places need mission stations now: The community in East Shelby at the junction

of routes 150 and 74; West Shelby on West Warren street and south toward 74 by-pass; the rural section on Kings Mountain and Waco and Cherryville roads north of Patterson Grove Church; the Toluca section north of Highway 18. Though not under the supervision of the Association, we are happy to announce that the Second Baptist Church of Kings Mountain has purchased a building in the Phenix Mill village and has a mission Sunday School in operation.

For the past several weeks the Missions Council has been faced with the task of recommending to the Association a successor to Lewis E. Ludlum, our most efficient Associational Missionary who recently resigned. After the consideration of several men who had been recommended to the committee, and after prayerful study, the Council now recommends Rev. Tom W. Bray, present Missionary of the Rowan Association, as the Missionary of the Kings Mountain Association, with the further recommendation that his work begin as of December 1, 1950 and that our Association bear the expense of his moving to Shelby.

THE ORPHANAGE REPORT

For 65 years the denominational Orphanage has given to the Baptists of North Carolina the privilege of being true friends and guardians to thousands of homeless boys and girls.

Last year 781 children were cared for. Each of these were helped physically, mentally, and spiritually. Fourteen graduated from Mills Home and five from Kennedy Home. The pastor, Rev. John Walton, baptized 70 at Mills Home.

The financial report for this year is encouraging. In response to the appeal made last year, Baptist of North Carolina gave more to the Orphanage than had ever been before, in one year.

On March 21st, this year, the Co-Executors of the Robert M. Idol estate turned over to the orphanage \$586,000.00 to be used in building a church at Mills Home, in memory of his Mother, an Infirmary, in memory of his Sister, and a vocational building which the trustees feel should be in memory of Mr. Idol himself. This is the largest single bequest the orphanage has ever received. An architect has been employed and plans and specifications are being prepared for these new buildings which should be started this year.

A number of changes in personnel have occurred this year. Our General Superintendent, Dr. Zeno Wall, having reached the retirement age 68, left the orphanage and returned to his home in Shelby. Superintendent W. C. Reed, of Kennedy Home, was asked by the Board of Trustees to fill the vacancy. Mr. and Mrs. W. A. Smith, of Boone, took over the work at Kennedy Home. Mr. Rimon Muth has become treasurer, due to the resignation of Mr. J. D. Fraley. Mr. J. Morse Grant was again elected editor of Charity and Children and has for his goal: 50,000 copies of this valuable paper going weekly into the homes and churches of our people.

The Orphanage approaches the new year with a challenge: the challenge of a big building program, and scores of homeless children calling for shelter and sustenance. We are confident that these will be met through the efforts of the capable leadership of faithful workers, and by means of generous hearts of North Carolina Baptist.

Let us continue to pray for our Orphanage, and give regularly and generously to it and thus help carry on the great work being done at both of our homes.

PUBLIC MORALS AND CIVIC RIGHTEOUSNESS

Cleveland County, as a whole, is in better condition morally, than when Beer and Wine were sold legally. However, we still find that Wine and Beer are brought into our county, and also that bootleg whiskey is being sold. We are aware that divorce and crime are still our greatest problems.

To combat the forces of evil, we must as Christian people, march together, whole heartedly, under the banner of Christ. Our hope for the future is in Christian education. The principles of Christ taught in our homes, Churches, and Christian Colleges will do more than all the laws that can be passed. When we instill in the minds and hearts of people to live the Christian life, we will then be able to abolish wickedness.

The 1935 Legislature granted the legal sale of beer and wine in each county without a vote of the people. This condition remained until 1947 when the General Assembly reluctantly passed a law permitting counties to vote. Immediately after its adjournment many counties circulated petitions to secure a vote. Since March 1, 1948, forty-three counties have abolished the legal sale of both beer and wine. Two have voted to retain it. Nine counties now have petitions filed with the Board of Elections and several of these dates set. More than half of the counties in the State will be bone dry when these have voted.

Governor Scott is determined that the people of North Carolina shall have a chance to vote on the liquor question during his administration. Plans are now underway to introduce a bill for a state-wide referendum in the coming General Assembly. Bills also will be introduced to repeat the gallon law, to ban beverage alcohol advertisement and to set up a supervisor of temperance education in the Department of Education so that the present program created by law will be carried out more effectively and efficiently.

Many counties which have outlawed beverage alcohol have set up definite plans for better law enforcements. Governor Scott through the State ABS Board has made great progress in eliminating the large amount of tax paid liquor shipped into the state by outside distributors. The Allied Church League has not only pledged its support to the program but has helped in many ways to carry it through.

Believing education to be one of the most forminalbe and permanent ways of combating the liquor problem, The League has set up an intensive program on alcohol education:

1. To assist the State Department of Education in promoting the courses on Alcohol Education, as required by law, in each high school by planning courses, the use of visual aid, and encouraging Allied Youth Posts.

2. To promote courses of instruction in the church schools and special training courses for teachers on alcohol studies.

3. To assist in arranging courses on alcohol education in denominational summer assemblies, camps, church colleges, and pastor's school.

4. To promote community studies of alcohol problems. Bring together various leaders—such as law enforcement officers, solicitors, judges of courts, welfare workers, ministers, doctors, educators, heads of hospitals, industrial and labor leaders and representatives of social service agencies to participate in the studies.

5. To educate the general public on the need for clinics and Alcoholic Anonymous clubs for the redemption and rehabilitation of alcoholics as a social responsibility.

6. To distribute up-to-date scientific literature on alcohol and its problems.

A large number of counties have carried through the suggested program in public schools under the leadership of the county and city superintendents. A number of the denominations affiliated with the League have worked faithfully at the program of education in the local church and in youth assemblies. The public and church schools have made use of our film service.

REPORT OF THE KINGS MOUNTAIN BAPTIST SUNDAY SCHOOL ASSOCIATION

In celebrating our one hundredth session of Kings Mountain Baptist Association we take great pride in this event and we should. We want to look at what our Sunday School has contributed to our rapid growth. We find that in 1856 our first Committee was appointed on Sunday School work. Only a few Churches reported having a School. It was first known as "THE NURSERY OF THE CHURCH," then "SABBATH SCHOOL." The Churches did not at that time know the value of a school. Not until 1890 did the thing really catch on fire. From this year on the Sunday School began to grow as the Churches began to realize the true value of the school. In the past fifty years the Sunday School has contributed much to the growth of the Association and by its teaching of God's word won many souls to him.

We have enjoyed a good year in our Sunday School work, and have had wonderful co-operation from our workers. Our district meetings were well attended and great interest was shown. We are glad to re-

port that 3 NEW SUNDAY SCHOOLS were started and all three resulted in Churches. Westover, one mile west of Kings Mountain and King's Chapel on Kings Road, this one sponsored by Shelby First Church. The Sunday School co-operated in the Sunday School Clinic held at the First Church, Shelby, in March this year.

We want to call to your attention some facts from our report of last Associational meeting. We reported 18,974 church members, 15,744 Sunday school members. That leaves 3,230 church members not enrolled in Sunday School. This is not so bad until we take off 30 per cent for children who are not Church members. When we do this we have 8,922 Church members that are not enrolled in our Sunday School. These figures should really put each one of us to work and not be contented until EVERY CHURCH MEMBER IS ENROLLED IN OUR SUNDAY SCHOOL.

Our Association planning meeting was held on Sept. 21st, at Elizabeth Church. A large crowd attended this meeting and we had with us Bro. Brooks, one of our State workers to outline our work for the coming year, by showing a Film Strip, as he outlined the work for the year. A good number of churches have already had their planning meetings. The workers reports have been most encouraging.

Some of our Churches have provided more space for more people in their Sunday Schools and some have plans to do so in the near future. Many of our people attended Ridgecrest and Caswell and reports are we will have the largest attendance this coming year than ever before. We would like to see every Church, have in their budget, provisions for every one who can go to one of these meetings. So many young people surrendered for full time service for the Lord while attending the conference.

Reports from Vacation Bible Schools are most encouraging this year. Most of our Churches are now realizing the great importance of these schools. We have here a great opportunity to teach our boys and girls God's word and win them to Christ. We do not see why any Church would let this glorious opportunity go by and not take advantage of it. Plan now to have one in your Church if you have not had one in the past.

We are indebted to our Associational Missionary, Lewis Ludlum, who has now resigned to work in the Pilot Mt. Association for his splendid work in helping promote the Sunday School work. Also to all the Associational Officers for their working with us in this glorious work of our Lord. Our prayer is that every one will work diligently to make this year the greatest ever enjoyed by Kings Mountain Baptists.

REPORT OF THE BAPTIST TRAINING UNION

Jesus in his Great Commission, said "Go ye," "baptise," "teach." Many of our churches have been reasonably faithful in carrying out these commands of our Lord. The words that follow apply particularly to the Training Union—"teach them to observe," or to do, "all things I have commanded you." In the Training Union we learn to do by doing. We learn to observe these things by practicing the observance of them. The Sunday School teaches us **to know**; the Training Union teaches us **to do**.

It was a significant move some thirty odd years ago when this Association began to recognize and promote this phase of our work which deals specifically with the training of the individual church member. Through the years the Training Union has developed from a small beginning for children to a fully graded organization including all the members of all the churches. Just as the Sunday School had to overcome the idea of being only for children, so the Training Union is now struggling in some of the churches in our Association to get those churches to grasp a vision of a useful member, trained in the camp of our denomination—adults as well as children receiving this training.

The Training Union has as a distinctive principle "individual development by individual participation." There is no other organization whereby our members may be developed into useful citizens of the Kingdom. Do you wonder so many of our churches have so many useless members? Truly, an uninformed Baptist is an unenlisted Baptist.

Preparedness is one of the first laws of self-preservation. Our members will be prepared for victorious living, for usefulness in the kingdom of God; our churches will be prepared to carry out the program of Jesus to a fuller degree because they have prepared workmen; and the total program of our Lord will more fully be brought to pass when the churches support wholeheartedly this training program.

When our pastors come to recognize the Training Union as being for adults as well as juniors, then we have indeed made progress. When our Sunday School officers and teachers realize that the main hope for having more and better trained workers lies in the churches' training these workers in the Training Union; when our pastors realize that the unenlisted, inactive, uninformed church member can be made useful and informed through the training organization; when each organization of the church realizes that it can do more and better work if it will seek to enlist and develop all members in the Training Union, then truly we will have the proper conception of this important phase of our work.

Here are some comparative figures as gathered from the Minutes of last year's session of our Association and from the Letters presented to this session.

Since she is not here her Mother, Mrs. Frank Elam, who has shared in all phases of Christian Endeavor is with us and we recognize her at this time.—Mrs. Elam.

MINUTES OF THE 56th ANNUAL SESSION OF THE KINGS MOUNTAIN WOMAN'S MISSIONARY UNION

MORNING SESSION

The Fifty-Sixth Annual Session of the Woman's Missionary Union of the Kings Mountain Association was held with the Zion Baptist Church, Shelby, North Carolina, April 26th, 1950.

Mrs. W. P. Biggerstaff, the Superintendent presided over the meeting, which opened at 10 o'clock for the morning session. The theme for the days program was "That the World May Know." The Woman's Missionary hymn for the year "Christ For The World We Sing" was used for the opening hymn.

Mrs. Roland Leath of the First Baptist Church of Shelby, gave the morning devotional. She centered her thoughts around the story of Jeremiah and his building of the wall of the city of Jerusalem. She closed her discussion with prayer.

Mrs. Walter Davis president of the W. M. U. of the hostess church very graciously welcomed the Association to their church.

Upon motion made to dispense with roll call, and those that had registered up to this time be recognized as constituting the organization and those that would register later be included and that the program was in the hands of the delegates with whatever changes may be necessary was adopted as order of business for the day.

A business session was entered into and the roll of churches with Woman's Missionary Union showed there were 26 of the churches represented.

Visitors recognized were Mrs. Terry Smart of Forest City, N. C. Superintendent of Hickory Division of Woman's Missionary Union,

Rev. and Mrs. E. S. Elliott of Cherryville, N. C., Miss Hilda Mayo, State Young Peoples Leader and Miss Lydia Greene a returned Missionary of China. A large number of pastors of the Kings Mountain Association were also present.

The Superintendent appointed the following committees to serve for the year:

Nominating—Mrs. J. S. Farmer, Mrs. Hal B. Greene and Mrs. Arnold Kincaid.

Time and Place—Mrs. Hoyle Alexander, Mrs. W. D. Johnson, Mrs. B. F. Bird.

Appreciation—Mrs. E. B. Hicks, Mrs. Coleman Elliott, Mrs. Malcolm Wilson.

A-I Societies for past year were recognized as follows: Zion, Shelby First and Boiling Springs.

At this time reports from the officers of the Woman's Missionary Union were heard.

Mrs. W. P. Biggerstaff, the Superintendent, gave a very encouraging report of the work. Our work is worthy of praise, she said, "All goals in the Association had been met."

As a matter of information she told us that in 1922 a motion was made and adopted that each society should pay 25 cents per member as expense funds and this to be sent in to the treasurer immediately after annual meeting each year.

Mrs. O. P. Hamrick, Chairman of the Training School and Margaret Fund told of the work of our Training School and Margaret Fund. She urged all the women to try to do more for them this next year.

Mrs. E. S. Elliott of Cherryville, N. C. Gaston Association, a very capable and interesting speaker, brought a wonderful and helpful message on Stewardship.

Next a motion was made and carried that the night session for the Young People's Organization be made a permanent thing and be held in connection with the Woman's Missionary Union Associational Meeting.

Miss Hilda Mayo, Raleigh, N. C., State Young People's Leader, spoke to us on the subject "Cooperation in the Work of the Lord." In her discussion she brought out that this is the 28th year of the Cooperative Program. And how it had improved over method of carrying on God's work, but that we need to go far beyond in our gifts and that if our program is to advance, it will have to be on the feet of our Young People, therefore, they must not be neglected.

Hymn—"We've A Story to Tell to the Nation."

Mrs. W. P. Biggerstaff presented Miss Lydia Greene, Missionary to China, who spoke on "The Work of Our Lord in China." For 24 years she worked in South China in Nursery and Kindergarten work.

Miss Greene told us of how so many, many little children came to them in the school and that a large number of them were often from homes that had never heard of Jesus Christ, the Savior of the World.

At the present, we know that dark clouds of Communism are hovering over China but said Miss Greene, there are those behind the clouds and dark curtains that will see to it that the lighted torch for Jesus Christ shall not go out even in the face of the criticism and persecution. She urged that we as Christians here in the homeland hold high the torch for Christ and live, pray and give that we may never have to undergo the fate of China.

At the close of Miss Greene's message, an offering was made and the amount of \$90.74 was given to Miss Greene to be used for the work in China as she thought best.

Mr. W. P. Biggerstaff, Chairman of the Associational Centennial program ask for cooperation from the Woman's Missionary Union president in getting together pictures of churches, Moderators and any other information that would be interesting, concerning the early years of the Kings Mountain Association.

Special prayer was asked for the extra Session of the Baptist State Convention Meeting in Charlotte, April 27, 1950.

The Morning Session of the Woman's Missionary Union was closed with Rev. W. P. Biggerstaff leading the prayer. Blessings on the noon-day meal was included in the prayer.

AFTERNOON SESSION

The Afternoon Session of Woman's Missionary Association was opened with the singing of the hymn "Jesus Calls Us."

Mrs. C. O. Greene led the devotional for the afternoon, assisted by Mrs. David Bean. In reading a number of scriptures in keeping with the theme for the day. Mrs. Frank Elam led the opening prayer.

Mrs. Terry Smart, Superintendent of Hickory Division of Woman's Missionary Union, spoke on the subject "Abounding in Mission Study." She said that reports show we are lacking in seeing that we have the best in Mission Magazines and periodicals and in using them in the best way possible in our homes and in our mission work.

The report of community Mission was read by the secretary in the absence of Mrs. Roy Propst, Chairman. This showed a gain over last year's work.

Hymn—"Rescue the Perishing."

Rev. Boyd D. Cannon spoke to us on the subject "The Work of Winning the Lost" and used for his discussion, I Thes. 1:8. Home Mis-

sions is one of the greatest means by which to reach the lost. He who saves his country for God; saves everything.

MINUTES OF YOUNG PEOPLES NIGHT

The Young People's Night of the Kings Mountain Associational Woman's Missionary Union had its first meeting with the Zion Church since 1942 with Mrs. J. S. Blanton presiding.

The program opened with the song "The Kingdom is Coming" led by Miss Cothenia Jones.

Little Caroline Cabaness of Zion Baptist Church gave the welcome. Then all the Sunbeams sang their theme song.

Mrs. J. S. Blanton, Young People's Leader made her report. It was very encouraging and showed that the work is progressing in every phase of its work. She recognized A-I organizations and the queen present.

Miss Cothenia Jones, Divisional Leader for Young People was presented to the Association and gave the goals for the years and urged us to see that they are reached.

The Shelby First Church gave the Star Ideals which was very impressive.

"O, Zion Haste," a beautiful pantomime was given by the Y. W. A.'s of Boiling Springs Baptist Church. It portrayed a beautiful lesson and was well given.

The Royal Ambassador's from Waco Baptist Church gave an interesting playlet, "Timothy's Tithe."

Rev. A. M. Kiser, Counselor for the R.A.'s in the Kings Mountain Association presented echoes from the different Camps by calling on some of the Young People to tell of their experiences while attending camp. Among them, Jean McSwain, who had dedicated her life to definite Christian Service.

At this time Mrs. J. S. Blanton introduced Miss Willie Kate Baldwin, a former Missionary to Nigeria now Dean of Women at Gardner-Webb College. She spoke mostly to the children and illustrated her talk with articles she had collected while on the Mission Field. All of this was interesting and meant much to the Young People.

Miss Mary Gordon Elliott, Chairman of the Business Women's Circle made an interesting report on the work in the Kings Mountain Association. We now have 16 circles who are members of the Federation with a membership of 270 business women. Also this Business Women's Circle was over the Charter Members of the State Federation of Baptist Women.

"IN BEHALF OF A DISTRESSED WORLD" RELIEF

Dr. Frank Means, Director of the Relief Committee of the Foreign Mission Board of the Southern Baptist Convention, in reporting on the relief efforts of Southern Baptists, states that through the Southern Baptist Relief Center in New Orleans alone, more than 5,000,000 pounds of goods valued in excess of \$4,250,000.00 were processed before it was closed on February 28, 1950. Germany received the largest amount of these relief goods from the New Orleans center. China came next. Other nations receiving more than 10,000 pounds of goods were Austria, Burma, Denmark, Finland, Hungary, Italy, Japan, Malaya, Pakistan, Palestine, the Philippine Island, Poland, Thailand and Yugoslavia. Shipments of under 500 pounds each went to Norway and Paraguay. Thousands of HOPE (Help Other People Eat) food boxes were packed at the center and shipped around the world.

Southern Baptists cash gifts for relief from August 1, 1947, to March 31, 1950, amounted to the sum of \$1,279,776.16. The majority of the Baptist World Alliance Relief Committee's financial support came from the Southern Baptist Convention, which contributed more money than all other bodies combined.

Another most important phase of Southern Baptists Relief program has been the resettlement of Displaced Persons in the United States. It is anticipated that the Displaced Persons Resettlement Office in New Orleans will be continued at least until July 31, 1951.

The Cleveland meeting of the Baptist World Alliance recognized a continuing need for relief in many parts of the world and encouraged member Baptist bodies to provide the resources to meet the apparent need. Due emphasis was placed upon the reconstruction of destroyed church buildings, and the construction of suitable chapels in unchurched areas or in areas where sizable groups of Baptists have been congregated by the emergencies resulting from war.

Mr. L. Howard Jenkins, chairman of the committee, commented upon Southern Baptists achievements through their relief efforts as follows: "Southern Baptists have every reason to be proud of their contribution to world relief. When they learn what their money has accomplished, I believe they will rejoice that they had a part in this worthwhile undertaking."

The Baptist World Alliance is restudying its whole program of relief. The Relief Committee of Southern Baptists is anxious to cooperate with the Baptist World Alliance Relief Committee in the plans which are formulated. Our relief program when it is finally outlined, will probably include relief projects for Burma, Japan, and Korea and probably still devote some attention to Europe, especially to Germany. Our Relief Committee, because Southern Baptists have work in Japan and are interested in Korean Baptists, will probably be interested in the work there.

Your committee suggests that all of our churches be urged to give material consideration to this great cause. Funds are needed now to continue the operation of the work of this committee. As the days go by the need will perhaps become greater. Therefore, we suggest that you take an offering immediately and that the amount be sent to Mr. M. A. Huggins, 119 Hillsboro Street, Raleigh, N. C., designated as relief funds for Southern Baptists Relief Center.

There will, no doubt, be other calls from this committee and we as individual Christians should always remember that our Lord and Master said, "Inasmuch as ye have done it unto one of the least of these my brethren, ye have done it unto me."
