Dr. Betty Knox - 1986-87 ACF Chairperson

In accepting this leadership position for the college, Betty Knox stated: "The primary reason why, in my busy life, I am devoting time and making gifts to Gardner-Webb is that an education at Gardner-Webb College involves the development of the whole person—physically, socially, spiritually, and intellectually. This costs money. Each year's budget is planned with an estimated amount in annual gifts from alumni, parents, and friends. Those gifts are important, anticipated income for the operation of the college. The Annual Fund is the vehicle through which the alumni can directly assist the college both now and in the future.

"I'm willing to give my time, talents, and money and am asking my fellow alumni to do no more than that. I am a visionary person and look to the future. Dr. Betty Knox is a member of G-W's class of 1954 and has served the college as a class chairperson for the Annual Fund, as

Dr. Knox brings a lot of training and experience to this position. After attending Gardner-Webb, she earned a bachelor's degree and master's degree from Appalachian State University. She received an education specialist degree and a doctorate in education from North Carolina State University. She is currently a consultant in resource development with the North Carolina Department of Community Colleges in Raleigh. Also, she is president of the Counseling and Educational Consulting Services in Raleigh, N.C.

Past employment includes Director of Development at Randolph Technical College in Asheboro, North Carolina. While at Randolph Tech, she led in a successful capital campaign for the institution. Dr. Knox has also led her church, as Building Committee chairman, through the first phase of its building program.

Dr. Knox is a member of several professional associations including Delta Kappa Gamma International; American Association for Counseling and Development;

American Association of University Women; and the National Council for Resource Development. She is currently working with the National Council for Accreditation of Teacher Education.

At the local level, Dr. Knox does volunteer work with the United Way of Wake County, and is a member of the Advisory Board for the Girl Scout Council. She has written several articles for professional journals, presented position papers at conventions, and testified before the President's Advisory Committee for Women.

She is married to John Jackson Knox, Jr., who is a consultant with the North Carolina Department of Public Instruction. They have one daughter, Joy, who is married to James Fairchild. The Fairchilds own and manage the Cherry Hill Farm in Charlottesville, Virginia.

The Knoxes enjoy traveling and working on home craft projects together. She also likes reading and swimming, when her schedule permits.

The Knoxes are members of the Crabtree Valley Baptist Church in Raleigh, where she has served as Sunday School Director, choir member and soloist, and is presently serving as a Deacon.



Broyhill Business Camp

What comes to mind when you think of summer camp? Most people think of swimming, softball, nature hikes and songs around the campfire. Yet, the 57 rising junior and senior high school students on the Gardner-Webb campus the week of June 22-27 attended an entirely different type of summer camp. These young people were participants in the sixth annual "Learn About Business" summer camp sponsored by the Broyhill Academy for the Study of Independent Concepts of Gardner-Webb College.

"The purpose of the camp," said Broyhill Academy Director Hank Garrity, "is to help students better understand how the business world operates.

"We want students to understand the necessity of profit, the free enterprise system, and to broaden their concept of job opportunities," said Garrity. "Most students go through school guided by one thought, 'Please the teacher'. Our purpose was to introduce students to the business world where they will work. The students were also given a chance to talk to business leaders in many different career areas."

During the weeklong camp, the students participated in a wide variety of activities, including seminars, guest speaker programs, computer programming classes, and class projects (such as a stock market competition). The group also took field trips to area businesses where they were able to observe firsthand the free enter-

prise system in operation. In addition, the students were invited to compete in an essay contest on the topic of free enterprise. The writer of the winning entry will receive a \$100 scholarship to the college of his/her choice.

Highlighting the week's off-campus visits were tours of the Broyhill Furniture Plant in Rutherfordton; Doran Textiles and Cleveland Memorial Hospital in Shelby; and Cash Farms in Gaffney, South Carolina.

In addition to field trips, students heard from guest speakers including David Ellis of Belk Department Stores; Rusty Hamrick of Kendall Drug Company; Marion McMillan of Smith Barney Harris Upham; John Edgerton of WBTV; Fred Flowers of Hamrick, Mauney, Flowers, Martin and Deaton, Attorneys-at-Law; Dr. Janie Carlton of the Davis School of Nursing; Beth Biggerstaff and Randy Wieck of Cleveland Memorial Hospital; Dr. Jack Hamrick, of Cleveland Orthopedic Associates; Jim Waddell of PPG; Kevin Jones, Gardner-Webb sports trainer; Barry Blackwell of Duke Power Company; Chuck Heath of Heath and Associates; John Vaughn of Southern National Bank; Dick LeGrand of Jaydee; Jack Vincent of Doran Textiles; John Barnhill of Artex International; Dr. Linda Combs, Education Advisor to Governor Jim Martin; and Risa Pless, Ben Davis and Ray Hardee of the Gardner-Webb staff.

Special guests included three of the directors of the Broyhill Academy: Paul Broyhill, retired chairman of the board of Broyhill Furniture Industries; Ann Heafner Gaither, executive vice

president of J.H. Heafner Company; and R.T. (Dick) LeGrand, Jr., president of Jaydee, Incorporated.

Most of the students participating in the seminar attended the camp as Broyhill scholarship recipients. Each high school in a five-county area selected three outstanding students to receive the Broyhill Academy scholarships.

He was employed for 10 years at Limestone as comptroller and assistant vice president for Business and Finance before assuming in 1981 his position as chief financial officer. Before joining the Limestone administrative team, he was employed by Scales Enterprises Incorporated of Pacolet, South Carolina, and as marketing representative by Burroughs Corporation of Greenville, South Carolina.

Mr. Clary is a graduate of the University of South Carolina with a bachelor of science degree. He is currently residing in Gaffney, S.C.

Mr. Clary's responsibilities at Gardner-Webb include the investment and endowment program and overseeing the accounting and business operation as the chief financial officer. He will also oversee the bookstore, physical plant operations,



and security and traffic control. He will serve on the President's Council with the other vice presidents.

Mr. Clary plans to marry Ms. Tammy Toney from Forest City on September 6, 1986.

He was the recipient of the 1983 Outstanding Young Man of America award by the Junior Chamber of Commerce. He was Director of the Saints Club, the LaFayette Masonic Lodge and the Hejas Temple of the Greenville Shrine. He is a member of the Macedonia Baptist Church.

Programs

Summer Theatre Workshop Held

After May graduation, Gardner-Webb College settles down for a long summer's nap. The campus is usually quiet and restful. But this summer there has been at least one place where a flurry of activity has prevailed. This place was Dover Theatre, home of the first Gardner-Webb Summer Theatre Workshop.

Eighteen participants gathered June 2 and were hard at work until July 31. The workshop incorporated all areas of the theatre and culminated with two plays running in repertory. They were Neil Simon's *The Odd Couple* and James Goldman's *The Lion in Winter*. The eighteen participants included six Gardner-Webb students, four members of the Greater Shelby Community Theatre, four high school students, two other college students and two faculty members.

The workshop director was Dr. Jeff Elwell, Director of Theatre and the assis-

tant professor of Communications Studies at Gardner-Webb. He also directed *The Lion in Winter*.

Dr. Elwell proposed the first workshop in the fall of 1985 for two reasons. The first was to create a continuity with the public in a newly revived theatre program. The second reason was to attract others in the state as future students in the Gardner-Webb theatre program.

The workshop was also set up to give current students and residents more theatre opportunities. Dr. Elwell saw this as an opportunity for the college to serve the local area by making entertainment available at a reasonable cost.

The workshop involved much more than just acting and directing. For example, three current Gardner-Webb students worked in the workshop as part of their internships under the Communications curriculum. Each participant was exposed

to more than one area of the theatre. Many of the actors and actresses helped design and build the sets for the two plays.

Stan Logan, a member of the Greater Shelby Community Theatre, was the director of *The Odd Couple* and also played Geoffrey in *The Lion in Winter*. He says, "Directing is a lot easier than acting. The hardest part is having control of one play and no control of the next."

The workshop has already yielded results. Chip Caldwell, a recent high school graduate from Kings Mountain, will attend Gardner-Webb this fall. "The theatre had a lot to do with my coming here. I've been in the theatre since the fourth grade and I plan to work in theatre when I graduate. The workshop has acquainted me with people and the theatre itself. It is sort of like an apprenticeship before the fact."

The workshop also attracted an out-of-state participant. Traci Schroeder is a

senior theatre arts major at Southwest Louisiana University. Her advisor suggested she work with Dr. Elwell since Elwell was the last to graduate from SW Louisiana with a theatre arts degree. She too reaped benefits from the workshop experience. "I plan to work with a stock company when I graduate. The experience here will help me tremendously because I am doing many of the things I would be doing in a stock company."

A current Gardner-Webb student, Patty Redman, used the workshop not only for experience but also to receive academic credit. Miss Redman, a senior communications major, was the costume designer for the two plays. She says, "I've gotten to know a lot more about the different aspects of theatre. This has helped me to get a good start in theatre."

Dr. White Makes First Formal Address

"Many of you, most of you, all of you know much, much more about Gardner-Webb in terms of past than I do, but I'm catching up on you. I'm interested, though, not only in the past and the present, but particularly the future.

"We started as an academy, high school, junior college, senior college, and now, lo and behold, a master's degree program. Remarkable progress! But as a senior college, we are still young. We aren't anywhere near where we want to go. The issue now is not one of survival; the issue is one of quality. We can survive without you (Heritage Club), but we can't have the quality we want without you."

"In the words of the Old Testament prophet, 'Without a vision, the people perish.' We need to have a vision. My vision for Gardner-Webb is in the process of becoming. It's embryonic, it's not all there yet. I have some features I'm thinking about, praying about. I have some key concepts. I'm thinking in terms of first-rate, successful, Christian, beautiful, caring, teaching, relationships. All those words we want to be associated with Gardner-Webb College.

"In effect, I want us to be the very best college of our type we can be. We're good, but we need to be better; and we need to be better in many, many ways. By becoming better, it's not only a product of wise use of resources, it's gaining more resources.

"What I would like to ask of you is, in the weeks and months to come, I would appreciate very much your sharing with me what it is you think Gardner-Webb is all about. Tell me about how it used to be. Tell me how you perceive it now. Tell me what your dream is. I have an idea that through the amalgamation of all our ideas can come a chart, or an objective, or a goal, or a direction for the next decade or so.

"Gardner-Webb can do much for you. I hope that in your church work, in your civic club work, and all the things that you do, that you will allow this college to be of service to you. We want to provide moral support. We want to provide speakers and leaders; we want to be of service to this community.

"As I read in the book *Lengthened Shadows*, service to community has been an undergirding watchword for this community.

"But now what does Gardner-Webb need from you? We need three things: (1) First of all, we need your continued interest and support. You don't know how much it thrills me to see you here tonight. The very act of your coming here says, 'I care, I'm concerned, I acknowledge things as they are, and I want things to be the best they can be.' (2) We want you to tell the story. There are many of us that have an evangelistic background and the ability to tell the story. Unfortunately, most of us only tell the story about the best shoe store we've found or some cloth that is on sale. But we need to tell our friends and our neighbors about this college and the things it is doing for the people who attend. (3) Perhaps most importantly, I would say to you that we need your prayers. This college has had a solid relationship with the church since its conception. That relationship has got to continue. We are going to be only as good as our relationship with our Master. We appreciate the prayers you have given for this

college and its personnel in the past, and we will want that in the future.

"Back in 1639, a gentleman by the name of John Harvard gave 779 pounds and half of his estate to build a university. That of course came to be known as Harvard. At that moment there was started in this nation a tradition of private support for private higher education. Since that time, virtually every private university and college in the United States has been undergirded by the private sector. Without it, the system of private education would not have made it."

"In conclusion, I would like to say just two things: Gardner-Webb is worthy of your pride. Gardner-Webb is worthy of your support. I believe that we have both, and for that we are grateful."

"The college has come a long way, but we're not where we want to go yet."

1950 Alumnus Hikes as Hobby

Dr. Bob Patterson, professor in the Department of Religion at Baylor University, says hiking "has been a lifelong hobby." Patterson has hiked the Grand Canyon, the riverbeds of Central Texas, and most of the east coast states.

Dr. Patterson received his A.A. in 1950 from Gardner-Webb. He received a B.A. from Baylor University with majors in English and religion. He also received an M.A. in Philosophy from Baylor and the M. of Div. and Ph.D. in Philosophy from Southern Seminary.

Dr. Patterson has pastored churches in Kentucky and Florida, and has served as an interim pastor and speaker at conferences.

A Reunion in Boiling Springs by Jay Jenkins

Jim DeBrew was a member of the class of 1936 at Boiling Springs High School in Cleveland County who had a rare gift.

Jim could whistle without seeming to part his lips. The thin trill sounded as though it was coming from far away. When the teacher picked it up and cocked his head, then scanned the classroom in futile search, the culprit was seated four feet from him.

The ruler hit the desk and stern warnings were issued. Jim always followed with another note or two, just for good measure. He was never caught, and none

of his classmates ever learned his secret.

Sadly, Jim won't be at the first and the 50th reunion in May, but he and his mysterious whistle will be among the memories of the survivors who gather at the Snack Shop at the crossroads to renew friendships and reminisce about an earlier time of simpler pleasures.

Boiling Springs Junior College, struggling offspring of a boarding high school, had been in operation in its three buildings for nine years when the high school class of '36 graduated. In those Depression days, college officials didn't worry about

building an endowment; their immediate concern was groceries for the dining hall next week.

On numerous occasions, E.B. Hamrick, local merchant, personally kept the college going. The Baptist church helped. When the college wanted a gym, lacking only money, the men of the community donated the materials and built it themselves. Good people, hard workers.

High school classes and college students alternated using classrooms and the gym. School started in mid-summer, then took a six-week break so the youngsters could

pick cotton at harvest time.

One of the highlights for the class came in its junior year, when the school first fielded basketball teams, with uniforms yet. In one game hosted by a Rutherford County school, the gym lights were powered by an old generator whose hiccups made them erratic and fortunately distracted attention from play on the floor.

The class of '36 was blessed by a corps of competent teachers who had a sincere interest in the students and knew how to motivate them. Only later would their charges appreciate that good fortune.

The business heart of Boiling Springs was the crossroads, the intersection of two dirt roads. On the corners were a garage, a filling station, a general store and a sandwich company that made sandwiches that were peddled in textile mills. Nearby was a two-room post office.

The post office, an old brick structure, later gained literary notice. In the unheated back room, a Boiling Springs resident, W.J. Cash, wrote portions of his classic book, "The Mind of the South."

Members of the class of '36 whose return visits have been infrequent will find surprises awaiting them. It's Gardner-Webb College now, a thriving four-year institution on a sprawling campus with no worries about where the next meal is coming from.

There's a community hospital in place of the lone chain-smoking country doctor who once served the area. There's a drug store, an apartment complex and a smart volunteer fire department. For years, the Baptist church was the only one in town; now the Methodists have one. The population has swelled to 2,500.

All the surface changes that have occurred in Boiling Springs during the last 50 years are likely to have little effect on the old grads. Once we were young; now we are old. But when the talk and the laughter mingle in the Snack Shop, somehow that won't matter.

Cat Tale Starts with Horror, Ends with All 9 Lives Intact

The Rev. David Boan felt bad enough when he found the cat mutilated by two hunting dogs across the street from his First Baptist Church in Pageland, S.C.

His friend, Pageland Postmaster Nan Eubanks, had left Thomas, her beloved white-collared, black-and-white cat, in his care while she went to Birmingham, Ala., to visit her daughter.

The situation became worse the next morning when Boan, who had dug a hole in Eubank's backyard for the cat's casket, could not find the body on the sidewalk next door where he had left it.

Boan and another friend, Helen Smith, decided to bury the empty box with its blue chiffon bow without telling Eubanks they had lost Thomas's body. "There were a few words (said) over the empty box," Boan said.

Then Eubank's daughter called to say her mother was on the way home to exhume the cat so she could say goodbye to her dear companion.

Boan and Smith considered stalling her until they could plant a decomposed chicken in the casket.

"We decided that we were really going to help the lady out and spare her feelings," Boan said. "We couldn't tell her the cat was mutilated."

But about two hours before Eubanks arrived, when Smith went to clean out the cat's litter box and food bowl, she found Thomas—alive and hungry—in the guest cottage behind her home.

Smith put a poster on Eubank's back door telling her that Thomas was inside and well and came back to find Eubanks hugging her cat and weeping for joy.

"I thought, 'Am I crazy?'" recalls Eubanks, who cried all the way home from Birmingham because, she says, the once-

stray cat was the last link to her husband, Joe, who died about a year ago.

"Here I am running home because of Thomas and here they say he's all right and they were supposed to have buried him this morning. When I opened the door, Thomas stuck his head out and said 'meow.'"

The cat tale started after church on the night of April 20 and lasted until late the next afternoon.

Boan heard barking across the street from the church and found that two hunting dogs had treed and killed a cat. Police officers took the dogs to their owner while Boan and Smith inspected the dead animal with a flashlight.

"We were just assured that it was the cat we were given charge of," Boan says.

Boan took the collar off the cat Monday, then went to dig a hole for the casket, an infant one a funeral home donated. Forty-five minutes later, the body was gone.

"I was going to put it on the shovel and put it in the casket," Boan says. "There's no question in my mind a possum came and dragged that cat out of there."

A Trip to Graduation in 1935

Mrs. Bonnie Price, a resident of Boiling Springs, recently sent a thank-you note to Hank Garrity, Vice President for College Relations, and reminisced about attending a past graduation at Boiling Springs Junior College. The following is a section of the letter from Mrs. Price:

"Well, Saturday morning while I was sitting in the graduation exercises I got to thinking back over the many years that I had attended GWC graduations. I said to the lady next to me, 'I attended my first graduation here in 1935.' She had a daughter in the graduating class, but she looked at me like I was talking ancient history when I mentioned 1935.

I didn't share anymore with her, but I reflected back on that first time after I got home. It was one month before my 13th birthday. My mother had inherited a little cash money from her side of the house. My oldest sister had graduated from Beth-Ware high school one year before and remained at home because we couldn't afford to send her to school. So that spring, mother decided we'd come to graduation at Boiling Springs Junior College.

We had a new used Willis Knight and drove from our near Kings Mountain residence to Shelby and the parents debated whether to continue west on Highway #74 to the Lattimore crossing and have only 3 miles on a dirt road, or go south on #18 and have a dirt road from Zoar church. The shorter route on dirt won. The road was such a 'washboard'. I thought the doors would fall off the car. If we rolled the windows down the dust choked us. If we left them up we burned up.

We arrived late and sat on the back row in the Hamrick building. I was all ears and eyes. We heard the last few sentences of the address and then they gave out diplomas.

It is always fresh and thrilling to see young folk who have striven to receive their degrees."

1986 Volleyball Preview by Dr. Dee Hunt

Young and promising are perhaps the best descriptions of the women's volleyball players on the 1986 team. Losing only one senior from the 1985 roster, three seniors, one junior, six sophomores and two freshmen will comprise the Lady Bulldog squad.

Seniors Donna Hendrix, Donna Robertson and Lisa Stewart are expected to provide the skills and the leadership needed for a successful season. Hendrix and Robertson are strong, improved hitters and will also be effective in the blocking positions. Stewart has displayed quality defensive play as well as the ability to assume the setting role if necessary.

Sophomores Kim Haywood and Lara Sellers are young players, but as a result of 1985 playing time and hard work, they should make strong contributions to the squad. Other returning players expected to contribute are Rhonda Edwards, Shawn Medlin and Jenny Riddle.

Newcomers Lisa Tucker and Cindy Cook will add depth and height, respectively, to the young squad. Tucker, a junior, has had previous playing time in the setting position, while Cook will be used primarily as a hitter and/or middle blocker. Susan Moore (Kings Mountain) and Tonya Sprinkle (Hendersonville), both

outstanding high school players, are new recruits whose talents should prove useful.

Dr. Dee Hunt, new coach of the Lady Bulldogs, views the upcoming season with enthusiasm and optimism. Concentrated practice sessions and a summer conditioning program are expected to be two important factors for the season's success, according to Dr. Hunt. Also, concentrated efforts will be made to help ensure team unity and self-worth.

This year's schedule boasts seven home tri-matches. The players will be returning to campus early in order to prepare for their first home matches on September 8.

1986 Spring Sports

1986 proved to be a good year for spring sports at Gardner-Webb, even though it was not as good as anticipated.

The baseball team failed in its bid to make the District 26 tournament for the second straight year. However, they did defeat three of the four teams in the tournament. Injuries to key players during the middle part of the season proved costly for the Bulldogs.

Junior outfielder Jeff Spargo hit .387 and was selected to the All-District 26 squad. He had an amazing on-base percentage of

.645 against district opponents. Freshman outfielder Scott Lee, who missed the last 15 games of the season, hit .406. Junior catcher Mark Ellis hit .349, and junior second baseman Mike Cheek hit .326.

The men's tennis team had another successful year. The 'Dogs finished third in the District 26 tournament, their highest finish ever.

Leading the Gardner-Webb attack was Rob Land. He scored a rare double in playing the number one position and also recorded the best record on the team. This

was quite an achievement considering the competition the Bulldogs faced.

The ladies' softball team finished up very strong, winning six of their last eight games. Gardner-Webb finished second in the District 26 Independent tournament.

Mechelle Hamilton led the Lady Bulldogs with a .440 average, followed by Donna Robertson with .435, Lisa Stewart with .384, Andi Morris with .373, and Donna Hendrix with .366.

Ben Davis Drafted



Ben Davis was drafted in the fifth round by the Cleveland Cavaliers in the annual NBA draft in June.

Davis averaged 21.7 points per game and shot over 56% from the field as a senior. He was honored as a third team All-American.

In his career, Davis scored 2,039 points, had 550 rebounds, and 347 assists.

Head basketball coach Jim Wiles stated, "Ben is the best pure shooter I've ever coached and one of the best I've ever seen. His ability to get along with others and his ability to shoot the basketball could very well carry him in the NBA."

Ben joins a long list of former Bulldog basketball players who have continued their careers in the professional ranks. Other Bulldogs who have played professional basketball include John Drew, Artis Gilmore, George Adams, and Eddie Wilkins.

Coach Fish Optimistic for '86 Season

Gardner-Webb football coach Woody Fish has reason to be optimistic for the 1986 season with nine returning starters on offense and seven on defense.

"If we can mature on defense and pick up where we left off last season, while continuing to improve on offense, we can be a good football team," Fish stated.

The Bulldogs have shown steady improvement under Fish, now in his third season. The 1985 campaign ended with a 6-5 record, only the fourth winning season in Gardner-Webb's football history.

During last season, the Bulldogs displayed the most balanced offensive attack since Gardner-Webb first played as a four-year school in 1970. With ten starters and the split back veer offense returning, the offense should be even stronger.

The key to the offensive attack will be junior quarterback Jesse James. James, who alternated at quarterback last season, needs to regain the confidence he displayed early in the '85 season. He finished the season with 562 yards passing, but he connected on only 43 percent of his passes.

James' favorite target should once again be sophomore Kelvin Richardson, whose 39 catches earned him second team All-SAC-8 honors last season as a freshman. Junior Frank Cunningham (19 catches, 363 yards) and senior Tony Simpson (14 catches, 138 yards) are also very capable receivers. Junior Jimbo Early was a receiving threat out of the backfield as well.

Early and sophomores Tony Phillips and Chris Poston, along with freshman Darryl Middleton, a 1985 Shrine Bowl participant, should provide steady spectacular play in the offensive backfield. Poston, who

missed the '85 season, is a speedster who started in the defensive secondary two years ago.

The offensive line appears to be a strong point with four interior linemen returning. Junior Brian Wood, an All-District 26 performer last season, is back at center, and sophomore Thurman Leach is back at guard. Junior Jim Chappell and senior Chris Medford return at tackle.

On defense the Bulldogs face the unenviable task of replacing linebacker Darryl Perry (SAC-8 Defensive Player of the Year), end Wayne Hall (2nd team All-SAC-8) and guard Tim Hardie (2nd team All-SAC-8). However, returning and heading up the defense is first team All-American defensive back Eric Brewton. Brewton intercepted 10 passes last season and returned 3 of those for touchdowns.

Also returning are senior linebacker Ozzie Wright (90 tackles) and guard Daryl Griffin (56 tackles). Delmonte Hugh, who was injured last season, will be a valuable contributor at defensive end if he can recover from knee surgery. Sophomore Norman James, who played very well in the latter part of the 1985 season, should see considerable playing time somewhere on the defensive front. Senior Terry Lewis started at safety last season and has been moved to outside linebacker to better utilize a strong defensive secondary.

In addition, newcomers Barry McCabe, a transfer from Furman, and Robert Hill, a transfer from Western Carolina, are outstanding players.

Junior Mark Greene will return to handle the kicking chores, and Jesse James can handle the punting duties. Eric Brewton will again serve as a return specialist.
