## Spangler Gate Dedication Held To Remember Pat Spangler

The late R. Patrick Spangler was considered a giant among many — particularly among those at Gardner-Webb College. Former chairman of the Gardner-Webb College Board of Trustees and 1972 recipient of the Doctor of Humanities degree at the College, Spangler's name is carried on one of the Men's Residence Halls at the College. In addition, Spangler and his family built Gardner-Webb's Spangler Stadium in memory of his father.

Spangler adopted Gardner-Webb College as his own special labor of love for he "saw something down there that was unique."

It was a fitting tribute to such a man when family, friends, faculty and staff gathered in January to dedicate the R. Patrick Spangler Campus Gate at Gardner-Webb.

"A College like Gardner-Webb is blessed with few people who give extraordinarily of themselves and their time. Pat Spangler is certainly one of those individuals," said Dr. M. Christopher White, Gardner-Webb College President. "Pat Spangler's persistence is the major reason the College has much

of its campus today — including the site of the Spangler Gate."

Eloise Spangler, wife of the late Mr. Spangler, shared that the property on which the Gate now stands was one of the happiest acquisitions her husband made on behalf of the College.

It was through the generosity of Carolina Freight Carriers Corp. in Cherryville that the Spangler Gate now stands at this corner. Spangler was a long-time member of the Carolina Freight Board of Directors.

Mrs. Spangler said at the dedication, "Pat told me not to erect any monuments to him, so when Carolina Freight told me of their very generous memorial for Pat I suggested Gardner-Webb. There is no more fitting place and need than the main corner of the College to identify Gardner-Webb College."

In dedicating the gate Dr. White noted, "People do not build gates around items that have no value. That which is behind the gate is special. 'The Webb,' as our campus is fondly called, is special. The rolling landscape, green grass and trees, the

springs, brick buildings and athletic fields form a beautiful montage."

Dr. White shared that at one point in his career, Spangler worked three days each week to raise money for the College. "Pat led by example, by giving," White said, "For generations to come, the Spangler Gate will symbolize that spirit of giving. It is a challenge to all of us."

Words taken from the litany of dedication read, "O Lord, may this gate stand for generations as a symbol -- a symbol of a man. But more than that, may it stand as a symbol of welcome to this institution of academic excellence in a Christian environment." ■

## Andersen Foundation Gives \$200,000 To Gardner-Webb

Gardner-Webb College has been named the recipient of a \$200,000 unrestricted gift by the Andersen Foundation of Bayport, Minn.

The Andersen Foundation is noted for its support of private institutions not accepting state or federal funds. Since beginning its regular support of Gardner-Webb in 1982, the foundation has contributed a total of \$685,000 to the College.

"The generosity shown Gardner-Webb College by the Andersen Foundation is certainly appreciated," said Dr. Chris White. "Our association with the foundation has been long standing. That they view Gardner-Webb as being a worthy recipient of such a fine contribution is indeed an honor."

The Andersen Foundation was incorporated in 1959 in Minnesota

by the late Fred C. Andersen. Andersen was a director and former president of Andersen Corporation, which produced wood and vinyl-clad window and door units.

The foundation places an emphasis on higher education. Grants through the foundation also envelope cultural programs, medical research, health, hospitals and civic affairs. ■

## First Citizens Funds Production

First Citizens Bank was the underwriter for the production of Gardner-Webb College Theatre's sesquicentennial theatrical production, "A Time for Singing," earlier this year.

First Citizens Bank city executive Lin Robinson said, "First Citizens is pleased to be involved in this part of Cleveland County's sesquicentennial celebration."

According to theatre director John Brock, the funds were attributed to set construction, period costume rental, advertising and promotion and special events surrounding the production.

The play, by award-winning dramatist C. Robert Jones, was set in the 1940s at Boiling Springs Junior College. It portrayed a day when school officials, church and community leaders had to bind together to help the college endure financial strain.

It was through the intervention of these same people that the school was saved. The name was changed and the college ultimately became a fully accredited four-year institution. ■

## Tom Winninger Presents Seminar At Gardner-Webb

Noted national speaker Tom Winninger was on campus in January to present a seminar, "Sustaining Peak Performance," an intensive seminar directed to the art of building a more productive, self-sufficient team. Winninger pinpointed specific, immediately-usable techniques to improve productivity by isolating those reasons teams work.

Winninger's presentation combined key management techniques into a common sense approach to generating more results, with the right people in less time. He presented how the positive impact of the team concept of management can transform marginally performing work groups into cohesive, highly motivated, hard-working teams.

Winninger has proven, and presented, that the best way to win is effective strategy. He hales as his motto, "Why compete when you can win!"

Winninger serves as president on the Board of Directors for the National Speakers Association. He is one of only 95 professional speakers to have received the C.P.A.E. Award of Excellence in platform speaking. In addition, he has been published in over 50 trade journals.

The event was sponsored by the Broyhill Academy and the Broyhill School of Management at Gardner-Webb College. ■

The Klines have been long-time friends and supporters of Gardner-Webb College. Kline is a member of the Bulldog Club Board of

Directors and Mrs. Kline serves as secretary for the College's Board of Advisors.

"Gardner-Webb has always been a love of mine," she said, "I think the academic requirements have always been excellent, even when the school was small with few facilities, the academic requirements were just excellent."

Dr. M. Christopher White, Gardner-Webb College president, commented on the long-standing relationship the Klines have with the College and the generosity of the gift. "It is quite fitting that two people, who possess such a love of



music and of Gardner-Webb College, make such a fine donation as a piano."

The piano will be used for various campus functions in the Banquet Hall and the First National Lobby of the Dover Campus Center. ■

## Chris and Linda White Endow Athletic Scholarship

---

Gardner-Webb College President and Mrs. M. Christopher White have established the M. Christopher and Linda Fleming White Endowed Athletic Scholarship Fund at Gardner-Webb College.

The endowment is the third for the College president and Mrs. White. "It is my firm belief that the long-term stability of our College is directly related to the endowment," says Dr. White. Explaining that a significant amount of his work at Gardner-Webb is to build the endowment, Dr. White recalls a principle he says he learned from his father, "a person can lead best by example."

"It is with that principle in mind that Linda and I have established two scholarships in the past, and now our third," he says.

Dr. and Mrs. White established the Fleming-White Excellence in Teaching Award in 1987 to honor an outstanding teacher each year. This award, according to Dr. White, acknowledges the importance of the College's faculty. Earlier this year, the Whites established an endowed scholarship for the Christian Service Organization. "As a minister, the Christian Service Organization is important to me as well as to the College," says Dr. White, noting that Gardner-Webb has the largest number of ministerial students of any college.

The newly-endowed athletic scholarship gives preference to members of the Gardner-Webb tennis team.

"Linda and I both love athletics; we both participated through the high school level," says Dr. White. The

Whites also have two sons who are athletes. Their older son, Marty, lettered in tennis in high school and is currently a member of the tennis team at Gardner-Webb, where he is a sophomore. Their younger son, Andy, is the number one tennis player at Shelby High School, where he is a senior. He has won all-conference honors during each of his high school years.

"Athletics have been and continue to be a significant part of the Gardner-Webb tradition," says Dr. White as he ties together his family's interest and the College's interest in the area.

"We recognize a serious deficiency at Gardner-Webb in endowed scholarships in athletics, this endowment is part of our attempt to address the problem," he adds. ■

He served as a flight surgeon in the U.S. Air Force. A member of First Baptist Church in Statesville, he serves as a deacon. He is a member of the Iredell County Medical Association, having served as president, and the Statesville Rotary Club. He and his wife, Caroline Hayes Bentley, have three children. Dr. Bentley has served as a member of the Gardner-Webb College Board of

Advisors as well as two previous terms on the Gardner-Webb College Board of Trustees.

**Rev. Russell Fitts** serves as pastor of Zion Baptist Church in Shelby. Rev. Fitts attended Mars Hill College, Furman University and Southern Baptist Seminary. He has spent 30 years pastoring in Cleveland County, including nine years at Double Shoals Baptist and 10 years at Bethlehem Baptist Church in Kings Mountain.

A former Gardner-Webb College trustee, Rev. Fitts has also served on the general board of the Baptist State Convention and as moderator and president of the pastor's conference with the Kings Mountain Baptist Association. Rev. Fitts and his wife, Mary Camp Fitts, have two sons.

**Jack Isaacs** is vice president and area manager with BB&T in Shelby. He graduated from Appalachian State University with a degree in education. **Bettie Morris** graduated from Hollins College in Virginia with an associate's degree. She earned a nursing degree from Columbia Presbyterian School of Nursing in New York City.

**Mrs. Morris** is a member of First Baptist Church in Rutherfordton, where she serves as a Sunday School teacher, G.A. leader and librarian. She is also a member of the Rutherford County Library Board and is a Girl Scout leader. She and her late husband have four children.

**Bernard Parker** is a retired businessman, having worked as vice president and regional manager with Nationwide Insurance Company in the Southeastern Region. He attended Columbia Bible College, Far Eastern

## Astronomer Addresses Topic of Extraterrestrial Life

Noted astronomer Dr. Stephen J. Shawl of the University of Kansas was on campus in January.

Shawl, presented through the Harlow Shapley Lectureship Program and the American Astronomical Society, is a professor of physics and astronomy at the University of Kansas in Lawrence. Although his area of expertise is globular clusters, Dr. Shawl's range of topics includes polarimetry of variable stars, black holes, cosmology, extraterrestrial life, planetary exploration and astronomy education.

While at Gardner-Webb, Dr. Shawl conducted a public presentation, "The Search for Extraterrestrial Life."

The Harlow Shapley Visiting Lectureships are made possible through an endowment established in Shapley's memory.

Shapley (1885-1972) was active in the American Astronomical Society. He did epoch-making studies on color and magnitudes of stars in globular clusters.

As a result of his work he showed that our sun is located near the outer rim of the system of globular clusters. Before this discovery, astronomers had assumed that our sun had a central position in our Milky Way system.

Shapley proved conclusively that our sun is a star located nearly 10,000 parsecs from the center of our galaxy. Shapley did for the Milky Way system what Copernicus had done for the solar system. ■

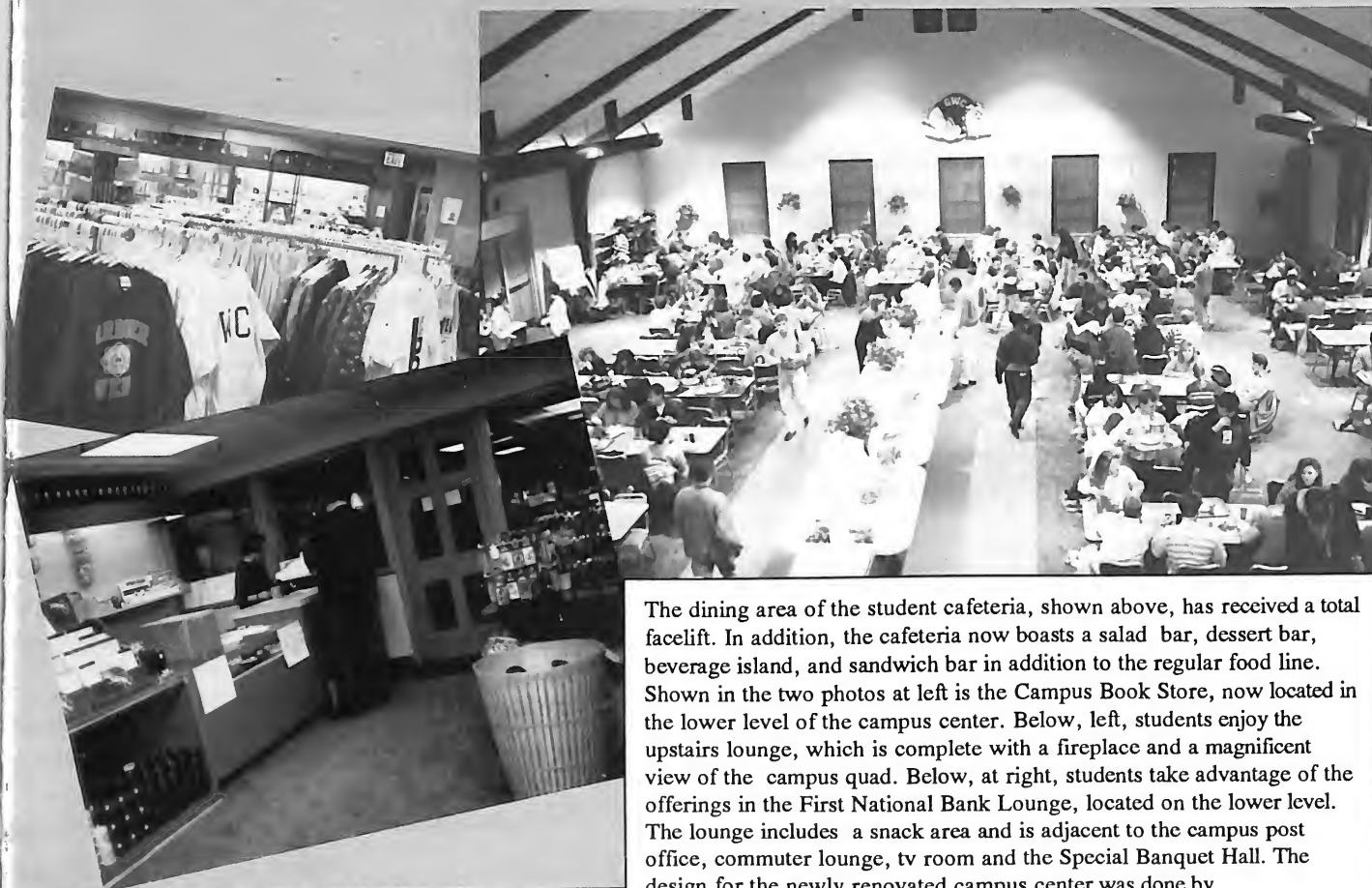

## Three Gardner-Webb Students Serving In Saudi Arabia

When Gardner-Webb College celebrated its Annual Festival of Lights early in December, luminaries were lighted in honor of two special young men.

Gardner-Webb students Tony McKnight and John Miller, both in the U.S. Army Reserves 846 Medium Transportation Unit, reported for active duty to Fort Lee, Va. just before Thanksgiving.

As a project to honor both McKnight and Miller and to remember all the U.S. soldiers now in Saudi Arabia, the Gardner-Webb Student Government Association sold luminaries.

The lights were part of the College's annual celebration and the \$200 raised was used to provide care packages to be sent to the Gardner-Webb students who have been called to serve their country.

McKnight, 24, is the son of Willie and Fay McKnight of Kannapolis. He served in the U.S. Army for three years before joining the reserves. A business major in his junior year at Gardner-Webb, he plans to pursue a career in political science. He has served as a Big Brother at Gardner-Webb and is active in his home church, where he recently spoke about the crises in Saudi Arabia.

Miller, 20, is the son of the Rev. John and Mary Miller of Salisbury. A sophomore mathematics major at Gardner-Webb, he has served as manager of the football team and also sings in the Gospel Choir.

Both McKnight and Miller were just three weeks away from completing the fall semester when called for duty. Each had to make personal, and educational sacrifices in order to serve.

Soon after the festival, a third Gardner-Webb College student, Nancy Woollard of Greensboro, was sent to Saudi Arabia.

Miss Woollard is a member of the 312th U.S. Army Reserve Evac Hospital Unit out of Greensboro. Miss Woollard, daughter of Bob and Nancy Woollard of Greensboro, is an operating room technologist at Forsythe Memorial Hospital in Winston-Salem. She is an associate's degree nursing major.

According to Miss Woollard, the 312th Evac Hospital Unit was the only unit called to Vietnam. At that time, it was the only unit that has been called to Saudi Arabia.

For the 25-year-old nursing student, the call to duty not only interrupted her education, but her personal life as well. Miss Woollard explained that her plans for this spring not only included graduation, but a May wedding.

With special permission from her colonel, Miss Woollard returned to campus to complete her final exams. At that time her unit was stationed at Fort Bragg awaiting assignment -- which was on slate for Christmas week.

In addition to the luminaries, Gardner-Webb remembered soldiers with a 4 by 10-foot Christmas card, which was signed by students, faculty and staff persons. The card was mailed to Saudi Arabia early in December. ■

## Behind the Scenes ... A Look at Kevin Jones

Every athletic program has people who work behind the scenes to make all athletic contests possible. Many times these managers, statisticians and trainers go unnoticed, and often, unappreciated. Behind the scenes of Runnin' Bulldog athletics is where Kevin Jones plies his trade as Gardner-Webb's Athletic Trainer.

Jones is an extremely vital cog in the Gardner-Webb athletic department. He describes the role of the athletic trainer as being, "the prevention, care and rehabilitation of athletic injuries."

However, he has carried his role beyond that definition. Jones assists coaches with travel plans, lodging arrangements and meal plans on many occasions. He also serves as counselor to those athletes who might need a friend.

When asked to further define the role of the athletic trainer, Jones

notes the prevention phase. "We make sure the athletes are in shape to prevent injury and that all playing fields and courts are safe," he says, "We also check all equipment to insure that it is in proper working condition."

The athletic trainer, according to Jones, must assure that immediate first aid is provided. This often involves transport to a doctor or hospital and serving as a liaison between the player, coaches and parents.

Often an injury is coupled with an extended period of rehabilitation. "The key," says Jones, "is making sure the athlete has the strength and flexibility to return to competition without risk of reinjury." This, he says, can be a very difficult chore when a player is anxious to return to competition. Patience and perseverance are the trainer's sermon

to the players who are in too big of a rush to return.

Jones says the stress and long hours are the most difficult part of his job. Jones says he cares about the athlete's pain, which is something he must deal with. And, there's the added pressure to get injured athletes healthy for competition. "And, when dealing with the health and welfare of the athletes you must always worry about the pressure of liability," he says.

Not only is Jones important to the athletic department, he does not turn away any student, staff member or faculty member that comes his way with any injury or pain. It is this type of caring that makes Jones a successful trainer and a true friend to the Gardner-Webb College family.

A 1984 graduate of Lenoir-Rhyne College, Jones holds a bachelor's degree in physical education with an emphasis in athletic training.

Following graduation, he came to Gardner-Webb as athletic trainer and earned a master's in physical education in 1986.

Since joining the staff at Gardner-Webb, Jones has completed his certification as an athletic trainer and is now a member of the National Athletic Trainers Association. He is also a member of the National Association of Intercollegiate Athletics, Athletic Trainers Association and Chairman of the South Atlantic Conference Athletic Trainers Committee. Jones has also worked as a student trainer at Lenoir-Rhyne College and as an athletic training intern with the Philadelphia Eagles.

### Gardner-Webb Initiates Athletic Hall of Fame

Gardner-Webb President M. Christopher White, has announced the formation of the Gardner-Webb College Athletic Hall of Fame. The Hall of Fame will induct its first members in the Fall of 1991.

"Competitive intercollegiate athletics have long been a characteristic of Gardner-Webb College," said Dr. White. "Establishment of our Athletic Hall of Fame to recognize outstanding former student-athletes, coaches and supporters is long overdue."

The Hall of Fame is designed to recognize former student-athletes and other persons whose performance and/or contribution to the athletic program of the College has been outstanding. The Hall of Fame will perpetuate the noteworthy athletic tradition of Gardner-Webb College and bring honor to the inductees, their families and friends and the College. It will further the mission of the college as "an institution of higher learning based on Christian principles and high academic and moral standards."

The formation of the Hall of Fame is an important time in the history of Gardner-Webb Athletics. Athletic Director Ozzie McFarland stated, "Gardner-Webb's athletic history is filled with outstanding student-athletes, coaches and fans. We are very proud to have this opportunity to honor the most special of these. It is my sincere desire that the community and Gardner-Webb's alumni and friends will take an active interest in all phases of this project -- from the nomination stage to the induction ceremonies."

Nominations to the Hall of Fame may be made by anyone. To be eligible a former student-athlete must have attended Gardner-Webb at least two years, must have been truly outstanding, and must have been of good character. Athletes must have ended their intercollegiate competitive tenure five years prior to nomination to be eligible.

Nominations are reviewed each year by a committee appointed by the President. Chaired by the Director of Athletics, the committee consists of three college administrators, the Bulldog Club President and three anonymous Gardner-Webb alumni named due to their widespread knowledge of Gardner-Webb athletics. The senior administrative staff has final approval of any candidate.

Selections are made in the summer with induction ceremonies held during the fall football season. A permanent plaque for each inductee will be displayed in the Bulldog Room of the Lutz-Yelton Convocation Center.

### SAC Gains NCAA Status

Gardner-Webb Athletic Director Ozzie McFarland said, "Since becoming a four-year college in the early 1970s, Gardner-Webb has displayed significant growth. The move to NCAA is simply another example of this growth and development."

The SAC has played football competition for the past 12 years but only since 1989 has the conference participated as an all sports league. The SAC offers championships and post season play in 11 sports programs including football, volleyball, men's soccer, women's soccer, men's basketball, women's basketball, baseball, softball, men's and women's tennis and golf.

Dr. Ken Orr, President of Presbyterian College and Chairman of the SAC Council of Presidents, said, "We are pleased to now have this association."

The South Atlantic Conference presently holds membership in the NAIA and has participated in many NAIA Championship programs for a number of years. The conference will continue to hold dual membership in the NAIA and NCAA until as a group the member institutions of the conference are eligible for NCAA post season competition. It is anticipated this eligibility will be available beginning September 1993. ■
